A G R E E M E N T

WHEREAS, CARMINE DISANTO and wife, OLINDA DISANTO, both of the City and County of Providence, State of Rhode Island, own a large area of land under water known as DYERVILLE POND south of Manton Avenue in the City of Providence, and

WHEREAS the City Council of the City of Providence desires to operate a controlled dump on a portion of said premises for the convenience of the inhabitants of the City of Providence and the disposal of the City's waste,

NOW, THEREFORE, This Agreement made and concluded this

day of

, A. D. 1963, by and between the

CITY OF PROVIDENCE, a municipal corporation created by the General Assembly of the State of Rhode Island, hereinafter called the "CITY" and CARMINE DISANTO and wife, OLINDA DISANTO, hereinafter called the "DISANTOS".

WITNESSETH:

In consideration of the premises and agreements herein mutually entered into, the parties agree for themselves, their heirs, executors, administrators and assigns as follows:

1. That the City shall have the right to dump into and fill that certain tract or parcel of land situated south of Manton Avenue in the City of Providence, shown as shaded area and designated by the letters A-D-C-D-L-A on the accompanying plan entitled, "Providence, R. I., P. U.--Engineering Office, City Property Section, Plan No. 062407, Date, March 13, 1963", bounded and described as follows:

Beginning at the northeasterly corner of Lot 232 on Assessor's Plat 34 at point marked "D" on the accompanying plan; thence southerly, bounded easterly by land now or formerly of Alessandro Morelli and wife Anna, two hundred thirty-one and 69/100 (231.69) feet to the southeasterly corner of Lot 232; thence northwesterly, bounded south-

westerly in part on said Morelli land and in part on land now or formerly of Leo Francisco, Jr., one hundred two (102) feet to the southwesterly corner of Lot 232 at point marked "A" on the accompanying plan; thence northerly, bounded westerly by land now or formerly of Anna H. Herndon, ninety-six (96) feet to point marked "B" on the accompanying plan; thence continuing northerly bounded westerly in part by said Herndon land and in part by land now or formerly of Mary C. Fagan, eighty-six (86) feet to the northwesterly corner of Lot 232; thence easterly, bounded northerly by other land of this grantor, thirty-six (36) feet to the northeasterly corner of Lot 232 and the point and place of beginning. Said parcel is further identified as being Lot 232 on Assessor's Plat 34 and contains 12,700 square feet.

2. This dump shall be operated by the City of Providence under the control of the Director of Public Works of said City during the period of operations and when said dumping operations are completed the surface will be covered with soil.

3. Until such time as the aforescribed premises are actually put to productive use, the City will reimburse the Diliantees for any increase in taxes assessed and paid in excess of the taxes assessed against said premises as of the time of the execution of this Agreement, provided such increase is due exclusively to the improvement of said area by reason of the dumping operations herein provided for, and provided further that such increase is in excess of the normal increase of assessments upon adjacent land in the area.

IN WITNESS WHEREOF, the parties have signed and executed these presents, the CITY OF PROVIDENCE, by WALTER H. REYNOLDS, the Mayor hereof, hereunto duly authorized by Resolution No. _____, approved _____.

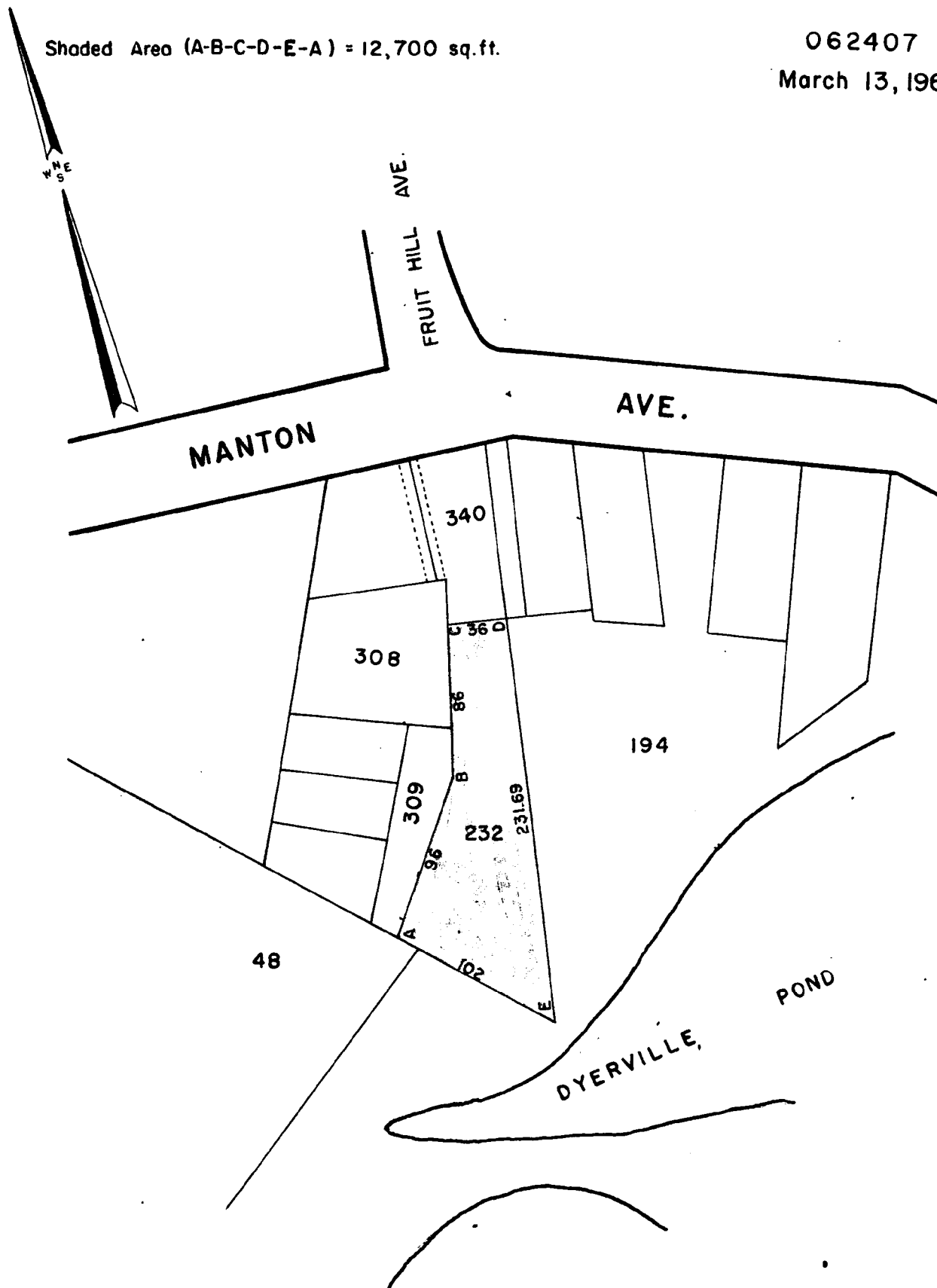
