Section 1. Sections 2-298 and 2-300 of Article XIX, of the Code of Ordinances of the City of Providence, entitled: "Elections", are hereby amended as follows:

Sec. 2-298. Payment of primary officials.

Every primary warden and clerk appointed under the provisions of Title 17 of the Rhode Island General Laws, 1956, or any amendment thereof or addition thereto, shall be paid fifty

dollars (\$50.00) for services rendered at the polling place on primary day. Every supervisor appointed under said provision of said Title 17 shall be paid forty-five dollars (\$45.00) for services rendered at the polling place on primary day; provided, however, that all clerks and wardens who complete biannually, training provided by the Board of Canvassers and/or the State Board of Elections shall receive the following pay: clerk, eighty dollars (\$80.00); warden, eighty dollars (\$80.00); and supervisor, seventy dollars (\$70.00).

Sec. 2-300. Payment of election officials.

Every warden and clerk appointed under the provisions of Title 17 of the Rhode Island General Laws, 1956, or any amendment thereof or

addition thereto, shall be paid fifty dollars (\$50.00) for services rendered at the polling place at elections. Every supervisor appointed under said provision of said Title 17 shall be paid forty-five dollars (\$45.00) for services rendered at the polling place at elections; provided, however, that all clerks and wardens who complete biannually, training provided by the Board of Canvassers and/or the State Board of Elections shall receive the following pay: clerk, eighty dollars (\$80.00); warden, eighty dollars (\$80.00); and supervisor, seventy dollars (\$70.00).

Sec. 2. This Ordinance shall take effect upon its passage.
