No. 512 **AN ORDINANCE** GRANTING THE CONSENT OF THE CITY OF PROVIDENCE TO THE ACQUISITION OF ITS INTEREST IN CERTAIN LANDS IN THE FEDERAL HILL EAST NDP URBAN RENEWAL AREA BY THE PROVIDENCE REDEVELOPMENT AGENCY

Approved December 28, 1972

*Be it ordained by the City of Providence:*

SEC. 1. Pursuant to the provisions of Title 45, Chapter 32, Section 25 of the General Laws of Rhode Island, 1956, the City of Providence hereby consents to the acquisition by the Providence Redevelopment Agency by eminent domain proceedings in connection with the Federal Hill East NDP Urban Renewal Area of the fee to and/or all of the estate or interest of the City of Providence in the following described lots or parcels of land with all buildings or improvements thereon:
