ORDINANCES SECOND READING

The following Ordinances were in City Council September 1, 1983 Read and Passed the First Time and are Returned for Passage the Second Time:

An Ordinance in Amendment of Chapter 1983-30 approved July 10, 1983, deleting the Appropriated Amount of \$169,796,240.96 and inserting in lieu thereof, \$169,801,505.76.

Be It Ordained By The City Of Providence:

Section 1. Chapter 1983-30 of the Ordinances of the City of Providence, approved July 10, 1983 entitled: "An Ordinance making an Appropriation of One Hundred Sixty-Nine Thousand Two Hundred Forty Dollars and Ninety-Six Cents (\$169,796,240.96) for the fiscal year ending June 30, 1984" is hereby amended by deleting the amount appropriated in title and inserting in lieu thereof "One Hundred Sixty-Nine Million, Eight Hundred One Thousand, Five Hundred Five Dollars and Seventy-Six Cents (\$169,801,505.76)."

Sec. 2. On Page 16 of said Ordinance delete the Grand Total "\$169,796,240.96" and insert in lieu thereof, "\$169,801,505.76".

Sec. 3. This Ordinance shall take effect upon its Passage.

An Ordinance in Amendment of and in Addition to Chapter 1797 of the Ordinances of the City of Providence, approved November 7, 1966, and entitled: "An Ordinance Approving and Adopting the Official Redevelopment Plan for the East Side Project No. RI R-4" as amended herein to rezone Lot 184 on Assessor's Plat 16, at the

corner of South Main and Transit Streets from R-4 to C-2 Zone.

Be It Ordained By The City Of Providence:

1. That chapter 1797 of the Ordinance of the City of Providence, approved November 7, 1966 and entitled, "An Ordinance Approving and Adopting the Official Redevelopment Plan for the East Side Project No. R. I. R-4" as heretofore amended, be and the same is hereby further amended as follows:

A. Paragraph (a) in Section (1) entitled, "Permitted Uses" under Section III B.3.6, entitled "C-2 General Commercial Zone" as contained in and set forth in Page 18 of that certain booklet entitled, "East Side Renewal Project, Official Redevelopment Plan" which is a part of the aforementioned ordinance be and the same is hereby deleted and the following substituted therefore:

(a) Except for that area designated as Lot 184 in Assessor's Plat 16 and as described in the following paragraph, C-2 General Commercial uses shall be permitted within this zone except for: Retail ice storage house; Apartment hotel or hotel; Auditorium; Bar; Bath, Turkish and the like; Bird store, pet shop or taxidermist; Blueprinting or Photostating; Catering establishments; Cleaning establishment with 40-pound capacity or more clothes cleaning units; Funeral Parlor; Parking Garage; Pawnshop; Rescue or temporary revival missions; Super-Market; Theatre; Second-Hand store; Upholstery shops, including automobile upholstery; Hospital or Sanitarium.

(b) For Lot 184, as set out and delineated on City Assessor's Plat 16, said lot being located along South Main Street at the northeasterly corner of South Main and Transit Streets, office use only shall be permitted.

B. Delete Map No. 2, Sheet 2 of 2, "Proposed Land Use and Zoning", dated November 12, 1981 as contained in that certain booklet entitled, "East Side Renewal Project, Official Redevelopment Plan" which is a part of the said Ordinance; and insert Map No. 2, Sheet 2 of 2, "Proposed Land Use and Zoning", dated 4/83 in its stead.

2. That said Chapter 1797 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.

3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.

An Ordinance in Amendment of and in Addition to Chapter 1982-49 of the Ordinances of the City of Providence, Approved July 8, 1982 and entitled: "An Ordinance Approving and Adopting the Official Redevelopment Plan for the Washington Park Revitalization Project" for the Deletion of Lot 17 on Assessor's Plat 59 and Lot 468 on Assessor's Plat 58 from Acquisition.

Be It Ordained By The City Of Providence:

1. That Chapter 1982-49 of the Ordinances of the City of Providence, approved July 8, 1982 and entitled, "An Ordinance Approving and Adopting the Official Redevelopment Plan for the Washington Park Revitalization Project" be and the same is hereby amended as follows:

A. Lot 17 on Assessor's Plat 59 and Lot 468 on

Assessor's Plat 58 designated for acquisition in Section 2, entitled, "Proposed Acquisition" under Chapter E entitled, "Plan Proposals" is contained in and set forth in Page 20 of that certain booklet entitled "Washington Park Revitalization Project, Official Redevelopment Plan, 1982" which is a part of the aforementioned Ordinance, be and the same is hereby deleted.

B. Certain maps of the aforementioned Official Redevelopment Plan hereinafter identified are deleted.

(1) Map No. 4 "Proposed Acquisition" dated 2/82.

(2) Map No. 5 "Disposition Map" dated 2/82.

C. Insert the following maps in its stead:

(1) Map No. 4 "Proposed Acquisition" dated 6/28/83.

(2) Map No. 5 "Disposition Map" dated 6/28/83.

3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.
