No. 319 AN ORDINANCE AMENDING CHAPTER 544 OF 1951 BY CHANGING A PORTION OF LOT 352 FROM AN R-3 GENERAL RESIDENCE ZONE TO A C-4 HEAVY COMMERCIAL ZONE; A PORTION OF LOT 365 FROM AN R-3 GENERAL RESIDENCE ZONE TO A C-4 GENERAL COMMERCIAL ZONE, A PORTION OF LOT 365 FROM AN C-2 GENERAL COMMERCIAL ZONE TO A C-4 HEAVY COMMERCIAL ZONE; PORTIONS OF LOT 439 FROM A C-2 GENERAL COMMERCIAL ZONE TO A C-4 HEAVY COMMERCIAL ZONE, AND PORTION OF LOT 439 AS SET OUT AND DELINEATED ON CITY ASSESSOR'S PLAT 49 FROM AN R-3 GENERAL RESIDENCE ZONE TO A C-4 HEAVY COMMERCIAL ZONE; SAID LOTS BEING IN THE VICINITY OF ELMWOOD AVENUE, AT POTTERS AVENUE AND HAWTHORNE STREET.

BE IT ORDAINED BY THE CITY OF PROVIDENCE:

SECTION 1. The Zoning Map accompanying and made a part of Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951, as heretofore amended, and entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations", is hereby further amended by changing a portion of Lot 352 from an R-3 General Residence Zone to a C-4 Heavy Commercial Zone; a portion of Lot 365 from an R-3 General Residence Zone to a C-4 General Commercial Zone; a portion of Lot 365 from a C-2 General Commercial Zone to a C-4 Heavy Commercial Zone; portions of Lot 439 from a C-2 General Commercial Zone to a C-4 Heavy Commercial Zone and portion of Lot 439 as set out and delineated on City Assessor's Plat 49 from an R-3 General Residence Zone to a C-4 Heavy Commercial Zone; said lots being in the vicinity of Elmwood Avenue, at Potters Avenue and Hawthorne Street, bounded and described as follows:

Beginning at the northwesterly corner of Elmwood Avenue and Hawthorne Street at the southeasterly corner of Lot 439 on City Assessor's Plat 49; thence westerly along the northerly line of Hawthorne Street, one hundred seventy-two and 06/100 (172.06) feet to a corner; thence northerly, crossing Lot 439, one hundred forty and 69/100 (140.69) feet to a corner; thence easterly, crossing Lot 439, fifty-eight and 85/100 (58.85) feet to a corner; thence northerly again crossing Lot 439, ninety-eight and 62/100 (98.62) feet to the southerly line of Potters Avenue; thence easterly along the southerly line of Potters Avenue to the Zoning Division Line of the present R-3, General Residence Zone and the present C-4, Heavy Commercial Zone (said Zoning Division Line being one hundred (100) feet west of and parallel with the westerly line of Elmwood Avenue); thence southerly along said Zoning Division Line and crossing Lot 352 to the southerly line of Lot 352; thence easterly along the southerly line of Lot 352, which also is the Zoning Division Line between the present C-2, General Commercial Zone and the present C-4, Heavy Commercial Zone to the westerly line of Elmwood Avenue at the southeasterly corner of Lot 352; thence southerly along the westerly line of Elmwood Avenue, one hundred fifty and 24/100 (150.24) feet to the northwesterly corner of Hawthorne Street and Elmwood Avenue and the point and place of beginning.



TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body

To change a portion of Lot 352 laid out and delineated on City Assessors Plat 49 from R-3 Residential to C-4 Commercial zone. Also, to change a portion of Lot 365 laid out and delineated on City Assessor Plat 49 from R-3 Residential to C-4 Commercial zone. Also, to change a portion of Lot 365 laid out and delineated on City Assessors Plat 49 from C-2 Commercial to C-4 Commercial zone. And also, to change portions of Lot 439 laid out and delineated on City Assessors Plat 49 from C-2 Commercial to C-4 Commercial zone. And also to change portions of Lot 439 as delineated on City Assessors Plat 49 from R-3 Residential to C-4 Commercial zone. And more fully bounded and described by metes and bounds as follows:

Beginning at a point in the westerly line of Elmwood Avenue at its intersection with the southerly line of Potters Avenue, thence southerly with the westerly line of Elmwood Avenue 240.24 feet more or less to a point in the northerly line of Hawthorne Street for a corner, thence turning an interior angle of 84 10' and running with the northerly line of Hawthorne Street westerly 172.06 feet more or less to a point for a corner, thence turning an interior angle of 94 57' 30" and running northerly bounded westerly by other land of the Church 140.99 feet more or less to a point for a corner, thence turning an interior angle of 84 57' 40" and running easterly bounded northerly by other land of the Church 58.85 feet more or less to a point for a corner, thence turning an exterior angle of 90 38' 20" and running northerly bounded westerly by other land of the Church 98.62 feet more or less to a point in the southerly line of Potters Avenue for a corner, thence turning an interior angle of 88 59' 10" and running easterly with the southerly line of Potters Avenue to the point and place of beginning.

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, April 9, 1968.

This referral is a request by the petitioner to change the zoning on a parcel of land bordered by Potters Avenue, Elmwood Avenue and Hawthorne Street and on the westerly side by a line described in the petition. Such action would involve Lots 352, 365 and 439 on Assessor's Plat 49. The zone change requests are as follows: Lot 365, presently divided into C-2 (general commercial) and R-3 (general residence), to be entirely zoned C-4 (heavy commercial); Lot 352, presently zoned C-4 and R-3, to be all C-4; Lot 439, presently zoned C-2 and R-3, to change the C-2 section to C-4 and to change a portion of the R-3 section (as delineated in the petition) to C-4.

On an inspection and photographic survey it was determined that Lot 365 contains a 2½-story frame dwelling presently unoccupied and in poor condition. Lot 352 contains a very large 3½-story frame structure. The first floor is occupied by a self service laundry and a television repair shop. The upper floors appear to be residential. The building is in very poor condition. Lot 439 contains a masonry church building and a wood auxiliary building both in good condition. It also contains a wooden building in very poor condition containing a second hand clothing store.

Since, in effect, the proposed change would be an extension of an existing C-4 Zone, and since only a small section of the newly formed C-4 borderline would infringe on a residential use,


