I have reviewed this department's records concerning property located at 25 Mount Vernon Street. This building became vacant in January of 1984 after a fire, and no work had been done on the property until this department issued a building permit in January of this year to SWAP for the renovation of the property.

At the present time, there are five liens on the property which total \$323.00. As of February 12, 1989, these liens incurred interest in the amount of \$127.53.

This department has no objection to the waiving of these liens in full, since the building probably would have been demolished if SWAP had not stepped in to renovate it.


