On Sunday, November 1 at 10:00 AM, runners from across the country will come to Rhode Island and participate in the new Blue Cross of Rhode Island Marathon. Held in Newport since 1976, the 1992 race will be a point-to-point 26.2 mile race through Warwick, Cranston and Providence.

The marathon will begin at the Mickey Stevens sports complex in Wawrick, continue through Cranston and finish in downtown Providence - Kennedy Plaza. With the downtown area hosting the finish we are confident that this new course will firmly position the Rhode Island Marathon as one of the top races in the country.

We are working closely with the Mayor's Office, Providence Police & Fire Departments, DPW, Parks Department and City Traffic Engineering to ensure the success and safety of the participants and spectators.

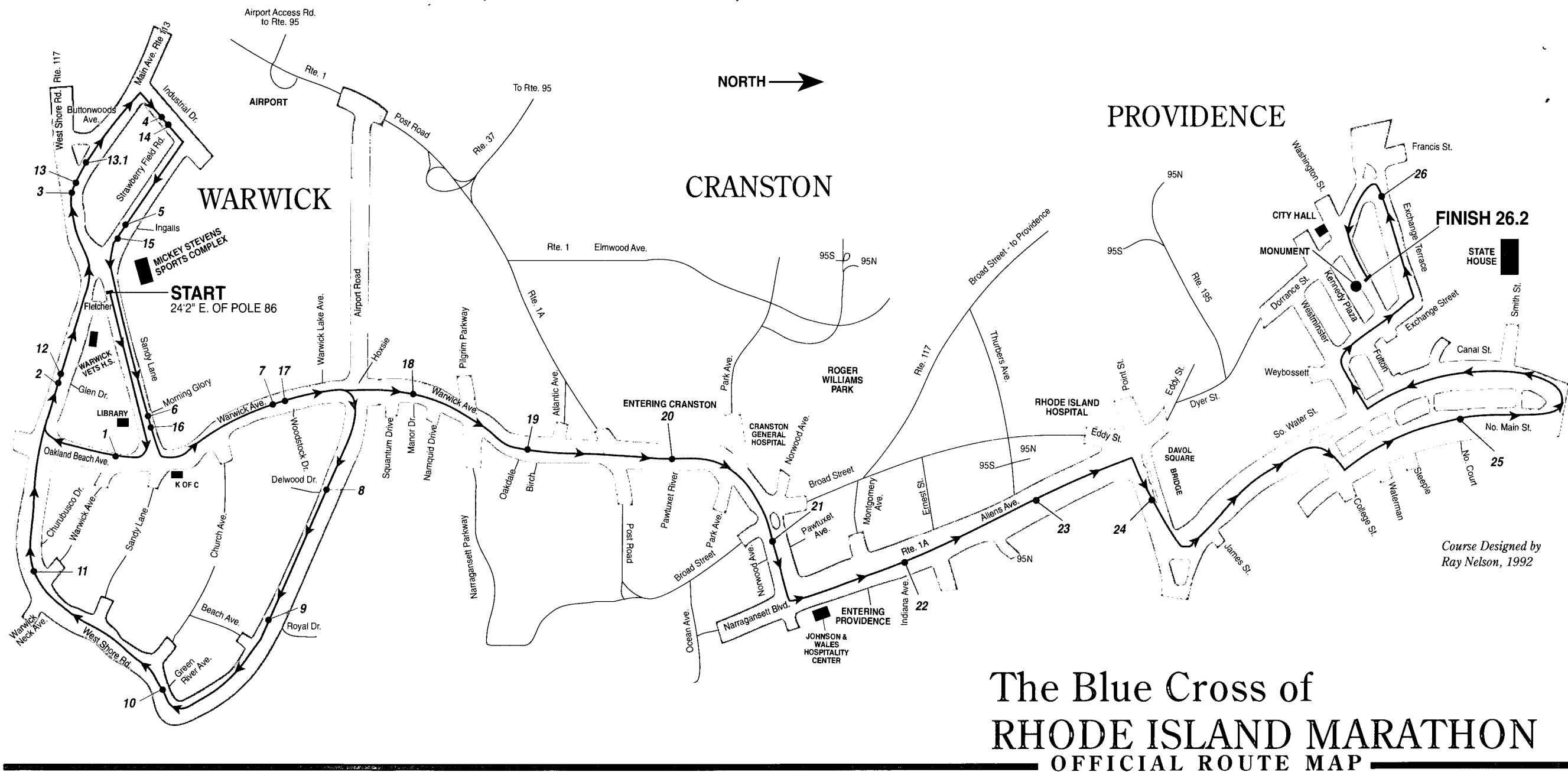

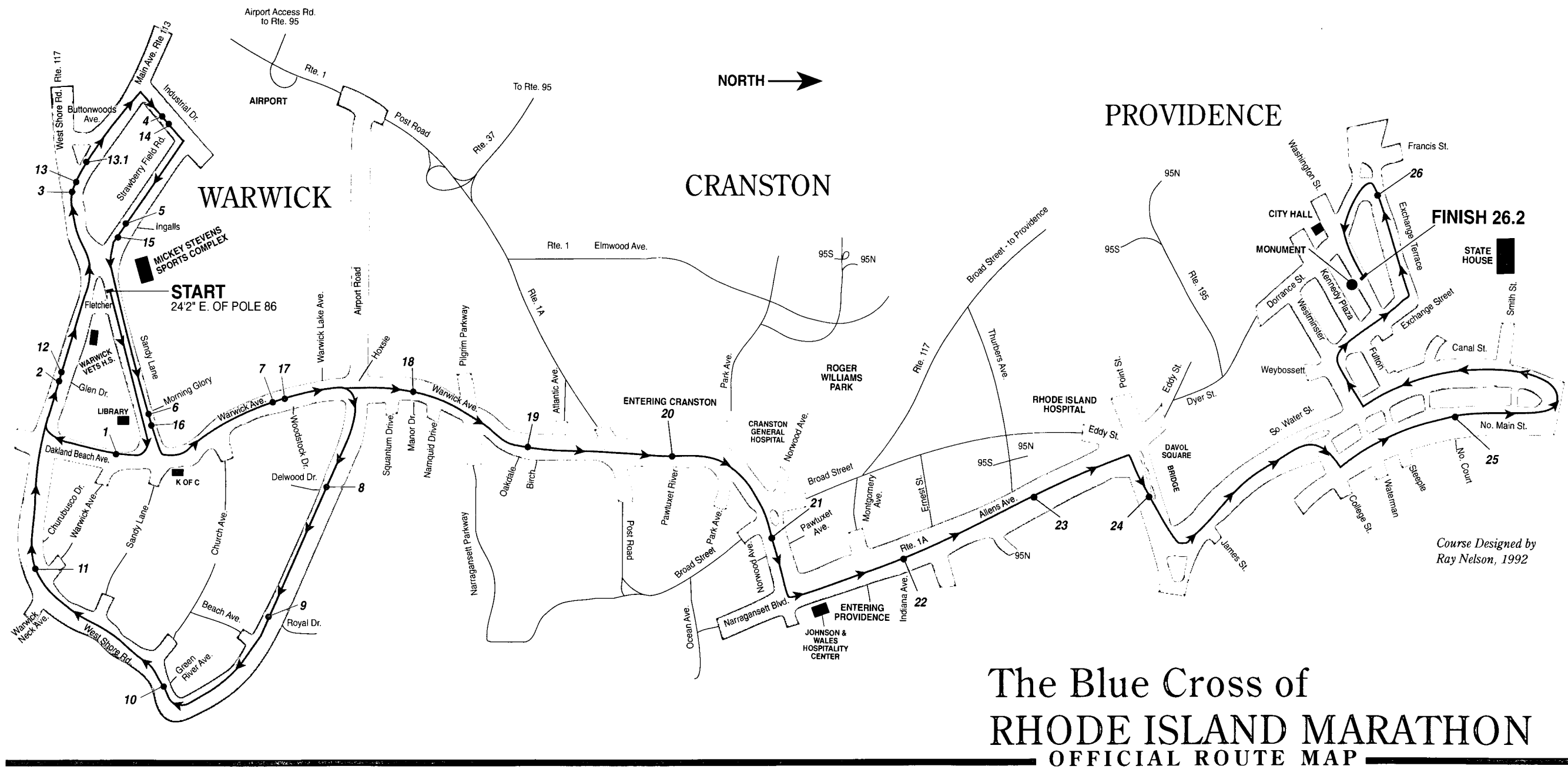
