## CHAPTER 1985-75

No. 434 **AN ORDINANCE** TO AUTHORIZE THE ISSUANCE OF  
REFUNDING BONDS NOT TO EXCEED \$26,000,000.

*Approved* August 9, 1985

**Be it ordained by the City of Providence:**

Section 1. A sum not in excess of \$26,000,000 shall be borrowed for the purpose of refunding the \$22,500,000 General Obligation Bonds dated September 15, 1982, payable September 15, 1983 through September 15, 1994. The City Treasurer, with the approval of the Mayor and the Committee on Finance, is authorized to accept and approve bids for refunding bonds not in excess of \$26,000,000, pursuant to Section 45-12-5.2 of the General Laws and other laws applicable thereto, to determine and approve the manner of sale, denominations, interest rate and other terms and conditions of the bonds, and to issue the bonds.

Section 2. It is hereby declared that the bonds authorized hereby will be within all debt and other limitations prescribed by the Constitution and laws of the State of Rhode Island.

Section 3. The \$22,500,000 General Obligation Bonds to be refunded shall be prepaid on September 15, 1988.


Section 4. This ordinance shall take effect upon its passage.


