# RESOLUTION OF THE CITY COUNCIL

No. 206

Approved April 28, 1988

WHEREAS, the General Assembly, in its January Session A.D. 1988, passed "An Act Relating to Property Tax Classification for the City of Providence" which is subject to approval of the Electors of the City of Providence at a special municipal election to be held May 24, 1988.

NOW THEREFORE, BE IT RESOLVED, That, at a special municipal election to be held on May 24, 1988, there shall be submitted to the Electors of the City of Providence, a proposition in substantially the following form:


"Shall an act passed at the 1988 session of the General Assembly, entitled 'An Act Relating to Property Tax Classification for the City of Providence', be approved?


AND BE IT FURTHER RESOLVED, That the warning of the election shall contain the question to be submitted and from the time the election is warned and until it is held, it shall be the duty of the City Clerk to keep a copy of the act available at her office for public inspection, and


BE IT FURTHER RESOLVED, That the City Clerk shall transmit forthwith a duly certified copy of this Resolution to the Secretary of State of Rhode Island, the Rhode Island State Board of Elections, and the Board of Canvassers and Registration of the City of Providence, Rhode Island and that the Board of Canvassers and Registration shall certify to the Secretary of State a copy of the question stated above to be submitted to the Electors of the City of Providence at the special municipal election to be held on May 24, 1988.


