Gentlemen:

This department has received a number of requests for the reduction of the speed limit on certain streets to 15 miles per hour.

The maximum and minimum speed limits are governed by the State of Rhode Island Motor Vehicle Code, and in particular, Chapter 14. In summarizing the numerous paragraphs of Chapter 14, the law specifies that local authorities may not reduce the speed limit of 25 miles per hour in any business or residence area. However, in this regard we do have authority to increase the speed limit, provided that an engineering and traffic investigation is made by an organized traffic engineering department. The professional traffic engineer feels that it is not reasonable or prudent to require a motorist to travel slower than 25 miles per hour under normal driving conditions.

Based on the above explanation you can see that any request for reduction in speed limit is fruitless, since we do not have jurisdiction in this matter.
