

RESOLUTION OF THE CITY COUNCIL

No. 405

Approved July 27, 2018

WHEREAS, There currently exists in the 02905 zip code area, a street known and identified as "Marion Avenue"; and

WHEREAS, There also currently exists, in the same zip code in the City of Cranston, a street known as Marion Avenue;

WHEREAS, There have been numerous mailing address issues as a result, including registration of voters in both cities; and

WHEREAS, The Providence Board of Canvassers has worked closely in collaboration with the Cranston Board of Canvassers and the United States Postal Service in order to determine a permanent solution. It was concluded that renaming both streets would resolve these issues; and

WHEREAS, On May 29, 2018, the Cranston City Council passed a resolution approving the name change of Marion Avenue in their city to Marion Avenue South; and

WHEREAS, There has been a public hearing, and notification to the Providence Marion Avenue property owners and abutters, and to all affected utilities and City Departments.


NOW, THEREFORE, BE IT RESOLVED, That Marion Avenue within the City of Providence shall hereafter be known as Marion Avenue North.
