TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body

J & B Associates, a Rhode Island General Partnership hereby petitions the Providence City Council to consider abandonment of the dead-end portion of the road which was formerly part of Eddy Street.

This 30 x 100 foot piece of property is located between Assessors' Lot #307 and #363 on Assessors' Plat #20 (see attached map). Both of these lots are owned by the petitioner and the property in question divides them.

It is bordered on the south side by an embankment for westbound traffic on Route 195. On the north side it is bordered by Clifford Street, across the street on Clifford Street is the Joseph J. Garrahy Court Complex. Other than the petitioner there are no abutters.

This property has already been examined by Irene Testa of the traffic control department and has been found to be of no use to the city for traffic purposes.

Being as this property has no value to the city, nor to any other parties, we feel that relieving the city of its liability and adding it to the tax rolls is a prudent and responsible action for the council to take.

We respectfully thank the Council for its consideration in this matter.


