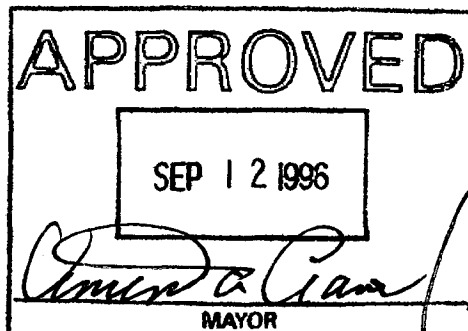
WHEREAS, The Providence School Board on June 27, 1994 approved the transfer of a 200 foot by 12 foot strip of land abutting A Street, and

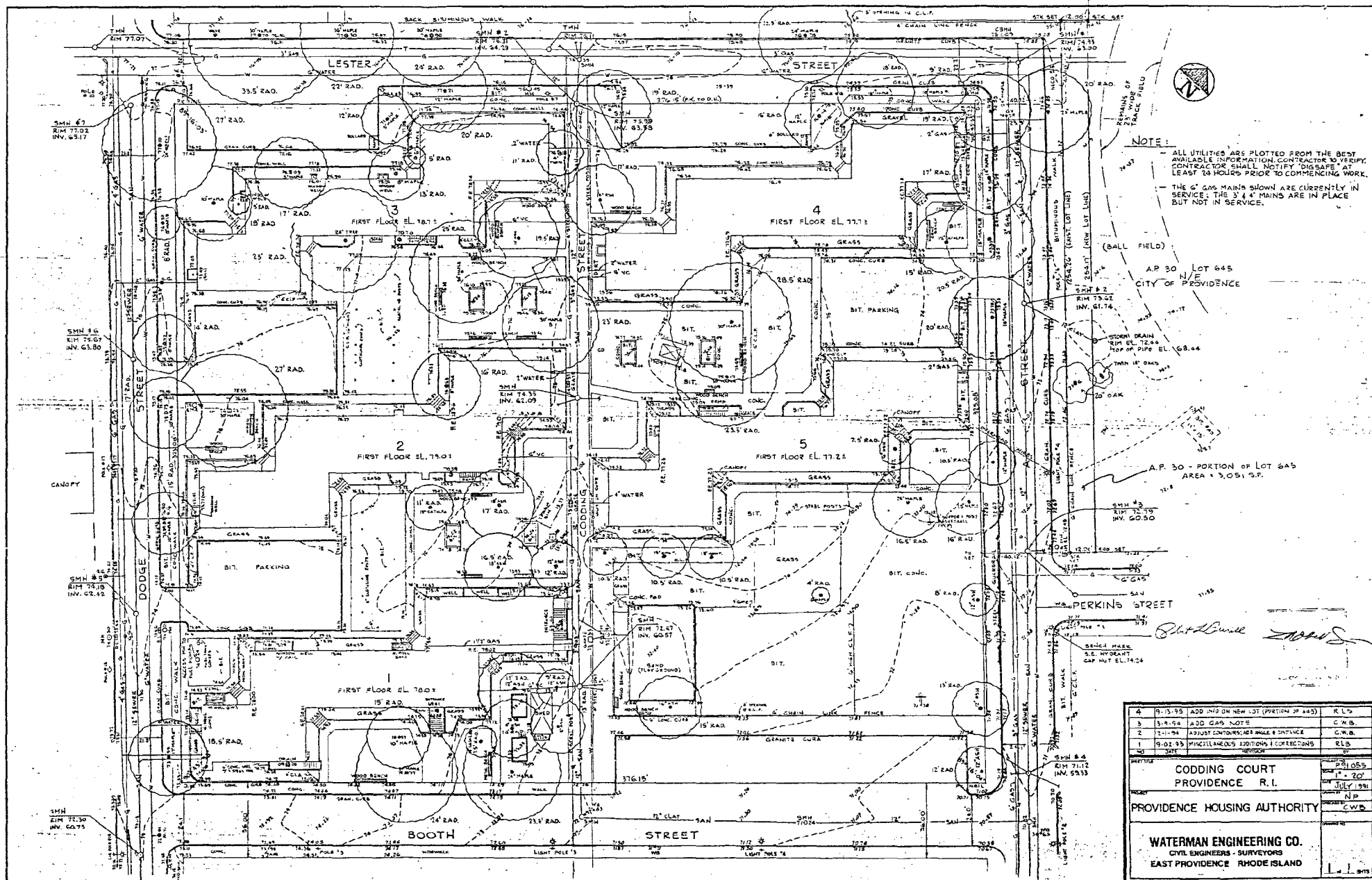
WHEREAS, The Providence School Department has ownership of Lot 645 on Assessor Plat #30; and


