

RESOLUTION OF THE CITY COUNCIL

No. 504

Approved October 16, 1989

Whereas, that fence located along the northbound lanes of RI Route 10 between the Union Avenue and Westminster Street exits has been broken in several places, and

Whereas, the adjoining residential area is densely populated, and many of these families have small children, and

Whereas, general cleaning and maintenance, as well as non-emergency repairs are needed to this fence, sidewalk, and guardrails, to provide an attractive buffer between the highway and the residential area,

Now, therefore, be it Resolved, that state Director of Transportation is requested to cause immediate repairs to be made to the fence along the northbound lanes of Route 10 between the Union Avenue and Westminster Street exits, and to cause more timely general cleaning and maintenance to be made to this area.



I have enclosed a copy of a resolution I intend to submit at the next meeting of the City Council. I am sending it prior to formal approval because I think there is a serious danger in that parts of fence along the Service Road to Route 10 northbound between the Union Avenue and Westminster Street exits have fallen down. The grade of the Service Road is fairly even with the highway, and there are many small children in this area.

We need to take care of the fence immediately, but beyond that, I would like to know who is responsible for maintaining this fence and the abutting sidewalk and guardrails. There is a very large depression in the sidewalk, and the guardrail should be repainted.
