## ORDINANCES SECOND READING

The following Ordinances were in City Council December 6, 1979, Read and Passed the First Time and Are Returned for Passage the Second Time:

An Ordinance Amending the Appropriation Ordinance Chapter 1979-30, Approved June 22, 1979, by Transferring the Sum of Twenty-Four Thousand Dollars (\$24,000.00) to the Providence Charter Commission.

*Be it ordained by the City of Providence:*

Section 1. Chapter 1979-30 of the Ordinances of the City of Providence, as approved June 22, 1979, entitled: "An Ordinance making an Appropriation of \$117,978,739.44 for the support of the City Government for the Fiscal Year Ending June 30, 1980," is hereby amended by appropriating the sum of Twenty-Four Thousand Dollars (\$24,000.00) to the Providence Charter Commission.

Sec. 2. This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of Article I, in General by Adding Section 23-32 to be Entitled: "Consumption of Alcoholic Beverages on Any Public Street, Public Sidewalk, Public Way, or Any Grounds Owned by the City of Providence," as Amended.

*Be it ordained by the City of Providence:*

Whereas, Repeated incidents which threaten the public peace, property, health and safety have occurred in the City, most specifically in the downtown area in recent days, and

Whereas, The situations have been seriously contributed to by public drinking by numerous individuals on the sidewalks, streets and parking lots downtown and throughout the City of Providence, and

Whereas, The Police Department has found it increasingly difficult to cope with the situation

due to the lack of any ordinance prohibiting the public consumption of alcoholic beverages, and

*Whereas*, In the interest of public peace, health and safety and the protection of public and private property, the City Council of the City of Providence does hereby enact the following Ordinance:

*Section 1.* Article I, in General, is hereby amended by adding Section 23-32 entitled: "consumption of Alcoholic Beverages on any Public Street, Public Sidewalk, Public Way, or any Grounds owned by the City of Providence, or on any licensed parking lot or land." It shall be unlawful for any person to possess, consume from and/or transport an open container of alcoholic beverages on any public street, public sidewalk, or public way or on any grounds owned by the City or on any licensed parking lot or land, within the limits of the City, except that it shall not be unlawful to so possess, consume from and/or transport such an open container at any event or festival duly licensed by the Bureau of Licenses which permits such possession, and/or consumption and/or by any restaurant, and/or licensed establishment patron while on the premises covered by said license, where said restaurant or other licensed establishment has obtained the proper permits as required and/or as prescribed by the City Charter of the City of Providence and/or the Ordinances of the City of Providence and/or the General Laws of the State of Rhode Island.

*Sec. 2.* Any person who commits any of the aforesaid offenses shall be punished by a fine of not less than One Dollar (\$1.00) nor more than Two Hundred Dollars (\$200.00) or by imprisonment of not less than One (1) Day nor more than Thirty (30) Days or by both such fine and such imprisonment. Each day any violation of this Ordinance shall continue, shall constitute a separate offense.

*Sec. 3.* This Ordinance shall take effect immediately upon its passage and approval by His Honor, the Mayor.

There was an article in the newspaper three or four days ago in regards to the Port Director of the City of Providence, Mr. Neary, Eugene Neary. In the article, he expressed some interest in a suitable job in Wilmington, Delaware and Mayor Cianci said he is going to make an attempt to try to encourage Mr. Neary to stay in the city. Then Mr. Neary follows with the remark, paraphrasing, if I will — It's going to take a lot of talking to make me stay — and the article went on to say that Mr. Neary was perturbed at the City Council — that there was investigating of illegal dumping down at the port. In Mr. Neary's remarks, he called the members of the City Council, idiots. I take first of all, exception to those remarks, Mr. President, since I am the Vice-Chairman of that Committee, the committee conducted itself with a very gracious manner, very cooperating manner, extending all opportunities which were available. Mr. Neary said in the article that he couldn't comprehend to give the answers, and I say again that at the committee meeting, we were informed by his immediate supervisor, Mr. Cesaro, on the day of the meeting.

I am very upset with Mr. Neary's remarks, everytime he appeared before our committee, we went out of our way to be courteous to him, try to be constructive in our criticism, and as a result of the committee's poll, I think several constructive steps were taken down at the Port of Providence.

The thing I am concerned about and I think many Committee Members expressed during subsequent meetings, and every time we asked any questions, he seemed to act perturbed or he seemed to act indignant, as though we had no right to ask him any questions, whatsoever, nonetheless the committee continued to be courteous to Mr. Neary, and I for one, believe that the report of the development to the committee was a good one until I read the article. And now Mayor Cianci says that he is going to offer Mr. Neary a raise. Well, in my honest opinion, after Mr. Neary's remarks in the paper I hope that he doesn't come to this Council to vote for a raise.

And it also is my opinion that if Mr. Neary needs my help to pack his bags to leave Providence, I volunteer.
