ORDINANCES SECOND READING

The following Ordinances were in City Council August 14, 1997, Read and Passed the First Time and are returned for Passage the Second Time:

An Ordinance in amendment of and in addition to Chapter 1983-4 of the Ordinances of the City of Providence, approved February 18, 1983 and entitled: "An Ordinance approving and adopting the Official Redevelopment Plan for the Silver Lake Revitalization Project" for the extension of the Project Boundary and acquisition of Lots 161, 162 and 178 on Plat 110.

Be it ordained by the City of Providence:

1. That Chapter 1983-4 of the Ordinances of the City of Providence, approved February 18, 1983 and entitled, "An Ordinance approving and adopting the Official Redevelopment Plan for the Silver Lake Revitalization Project", as amended by the following Ordinances of the City of Providence: Chapter 1984-21, approved March 23, 1984, Chapter 1987-9, approved March 11, 1987, Chapter 1992-47, approved November 25, 1992, Chapter 1995-12, approved June 9, 1995, and Chapter 1997-11, approved February 23, 1997, is hereby further amended as follows:

A. That an Exhibit A entitled "Description of Project Boundaries of the Silver Lake Revitalization Project" contained and set forth on Page I of the certain booklet entitled "Silver Lake Revitalization Project, Official Redevelopment Plan" which is part of the aforementioned Ordinance and the same is hereby deleted and the area encompassed by the following is substituted in its stead:

Exhibit A — 1997

Description for the boundaries of the Silver Lake Revitalization Project area

Beginning at the intersection of the Johnston Town Line and the center line of Jacqueline Drive;

Thence turning and running easterly along said center line to its intersection with the northerly lot line of Lot 33 on A.P. 111;

Thence turning and running easterly along said lot line to its intersection with westerly lot line of Lot 84 on A.P. 111;

Thence turning and running southerly along said lot line to its intersection with the northerly lot line of Lot 94 on A.P. 111;

Thence turning and running easterly along said lot line to its intersection with the westerly lot line of lot 94;

Thence turning and running northerly along said lot line to its intersection with the center line of Killingly Street;

Thence turning and running easterly along said center line to a point opposite the westerly lot line of Lot 14 on A.P. 111;

Thence turning and running southerly along said lot line to its intersection with the southerly lot line of Lot 14;

Thence turning and running easterly along said lot line to its intersection with the rear lot line of Lot 28 on A.P. 111;

Thence turning and running southerly along the rear lot lines of Lots 28, 27, 25, 23 and 22 to its intersection the easterly lot line of Lot 94 on A.P. 111;

Thence turning and running easterly along the center line of Plainfield Street to its intersection with the center line of Laurel Hill Avenue;

Thence turning and running northerly along said center line to its intersection with the center line of Eastwood Avenue;

Thence turning and running easterly along said center line to its intersection with the center line of Rhode Island Interstate Route 6;

Thence turning and running easterly along said center line to its intersection with the center line of Rhode Island Route 10;

Thence turning and running southerly along said center line to its intersection with the Cranston City Line;

Thence turning and running westerly along said City Line to its intersection with the Johnston Town Line;

Thence turning and running northerly along said Town Line to the point and place of beginning.

B. Entitled "Proposed Acquisition" under Chapter E entitled "Plan Proposals" contained and set forth on Page 15 of that certain booklet entitled, "Federal Hill East, Official Redevelopment Plan, 1977" which is part of the aforementioned Ordinance as amended to date:

2. That said Chapter 1977-15 of the Ordinances of the City of Providence as adopted and as heretofore amended, is hereby ratified and reaffirmed in all other aspects.

3. This Ordinance shall take effect upon passage and the City Clerk shall forward a certified copy to the Providence Redevelopment Agency.

An Ordinance approving and adopting the Official Redevelopment Plan and the attached restrictions for the Gorham Redevelopment Project.

Be it ordained by the City of Providence:

Whereas, The Providence Redevelopment Agency (PRA), pursuant to the provisions of the Rhode Island General Laws (RIGL) Title 45, Ch. 32, as amended, has formulated a plan entitled "The Gorham Redevelopment Project," (Redevelopment Plan) attached and made part of this Ordinance; and

Whereas, Providence 2000, *The Comprehensive Plan* has been prepared and adopted by the City Plan Commission and the City Council pursuant to RIGL Section 45-22.2 et seq, and is recognized and used as a guide for the general development of the City of Providence as a whole; and

Whereas, The said Redevelopment Plan's Project Boundary encompasses an area which has be designated "Redevelopment Areas" by the City Code of Ordinances, Chapter 20, as amended; and

Whereas, The City Plan Commission, which is the duly designated and acting official planning body for the City, has submitted to the City Council its report and recommendations respecting the Gorham Redevelopment Plan and has certified that said Redevelopment Plan conforms to the said Comprehensive Plan for the City as a whole, and the City Council has duly considered said report, recommendations and certification of the planning body; and

Whereas, A structural quality survey, conducted by the City of Providence, Department of Plan-

ning and Development, indicated that a number of structures have deficiencies that include serious deterioration. The Gorham Redevelopment Project Area is not restricted to, nor does it consist entirely of lands, buildings, or improvements which of themselves are detrimental, but is an area in which such conditions exist and injuriously affect the entire area.

Now, therefore, be it ordained by the City of Providence:

1. The Project is hereby designated as "The Gorham Redevelopment Project." The Project Area will be designated number thirty-six (36) in Redevelopment Area number four (4).

2. It is found and declared that the Gorham Redevelopment Plan Area contains blighted and substandard properties, some of which require demolition and clearance while others require rehabilitation and improvement. Some street patterns are not conducive to redevelopment and future viability. These problems include:

A. *Defective or Inadequate Street and/or Lot Layout.* The intersection of Reservoir Avenue at Downing Street does not allow for appropriate access to the Gorham Manufacturing Site and is both poorly laid out and in need of redesign. At the same time, the redevelopment of the Gorham Site will require that independent access be provided for the adjacent residential areas. The creation of a dedicated access to the residential area will require that a remedy be found for deficiencies at the intersection of Downing Street and Adelaide Avenue.

The reconstruction of the Roger Williams Avenue Bridge will necessitate a new access for properties located on Burrows Street. The new bridge will also enhance access to the Gorham site itself while also serving the interests of nearby residential areas.

B. *Obsolete or Aged Buildings, Not Suitable for Improvement for Conversion.* While there are a number of older buildings which suitable for

rehabilitation, there are also structures which are both aged and in dilapidated condition. Some of these, where the costs of rehabilitation is prohibitive, must be removed in order to promote redevelopment of the site.

C. *Inadequate Provision for Ventilation, Light, Sanitation, Open Space and Recreation Facilities.* There is a lack of public open space and recreational facilities near the Gorham Site itself. A portion of the Gorham Site will be dedicated to open space and recreational uses.

D. *Defective Design or Unsanitary or Unsafe Character or Condition of Physical Construction.* The vacant buildings create an extremely unsafe the residential and commercial areas surrounding the Gorham Site.

3. It is the intent of the City Council to use powers granted under RIGL 45-32-1 et seq., as amended, to acquire vacant and/or blighted properties, reduce density of housing, facilitate rehabilitation of deteriorated structures, provide site improvements, and provide for the orderly redevelopment of the project area.

4. It is found and declared, pursuant to RIGL 45-32-20, that:

A. The Gorham Redevelopment Project is feasible, conforms to the Comprehensive Plan, and if carried out, will promote the public health, safety, morals and welfare of the City of Providence. The acquisition of the real property in accordance with the Gorham Redevelopment Plan is in the public interest.

B. In order to implement and facilitate the effectuation of the Redevelopment Plan hereby approved, the City Council declares that the PRA be and hereby is authorized to utilize \$1,000,000 appropriated from the 1996 City of Providence Bond Issuance to carry out the Official Redevelopment Plan for the Gorham Redevelopment Project. The Redevelopment Plan contains adequate provisions to assure the expenditure of

funding in order to carry out the work of redevelopment.

C. The Redevelopment Plan will call for a reconfiguration of the intersection of Downing Street, Alvin Street, Reservoir Avenue and Adelaide Avenue. There will be a reconstruction of the Roger Williams Avenue Railroad Bridge. There will also be a right of way created for a new street connecting Burrows Street with Narragansett Avenue.

D. The Redevelopment Plan shall provide for payment for property which may be acquired by the exercise of eminent domain.

E. The Redevelopment Plan contains no provisions for the use of any financial aid from the federal government.

F. The Redevelopment Plan contains provisions stating that the controls contained within the Redevelopment Plan shall follow the Zoning Ordinance of the City of Providence, as amended.

5. The Gorham Redevelopment Project, is hereby approved, adopted and designated as the Official Redevelopment Plan for the Gorham Redevelopment Project Area and is herein incorporated by reference, made a part hereof and designated as "Exhibit A".

6. This ordinance shall take effect on its passage.

An Ordinance in amendment of and in addition to Chapter 1984-11 of the Ordinances of the City of Providence, approved February 10, 1984 and entitled: "An Ordinance approving and adopting the Official Redevelopment Plan for the West River Project No. UR R.I. 1-6" for the revision of the Regulations and Controls in the West River and Silver Spring Industrial Park.

Be it ordained by the City of Providence:

1. That Chapter 1984-11 of the Ordinance of the City of Providence approved February 10, 1984 and entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the West River Project No. UR R.I. 1-6" as amended by the following Ordinances of the City of Providence: Chapter 1987-7 (March 11, 1987); Chapter 1988-41 (November 10, 1988); Chapter 1991-9 (March 28, 1991); Chapter 1993-45 (October 29, 1993); and Chapter 1994-18 (June 13, 1994) is hereby amended as follows:

A. Part a. Permitted Uses of Section 4. "Regulations and Controls" to be applied under Chapter B. "Planning Proposals" is amended by adding the following:

- In addition, the uses permitted by right in Section 303 — Use Regulations of the Zoning Ordinance of the City of Providence in an M-1 Zone under Use Code 41 — Finance, Insurance, and Real Estate, are permitted for Parcels 10, 11, 12, 13, 14, and 15.

2. That said Ordinance, as adopted and amended, be and the same is hereby ratified and confirmed in all other respects.

An Ordinance amending Providence 2000: The Comprehensive Plan, Chapter 1994-52, No. 798, adopted on December 27, 1994, as amended.

Be it ordained by the City of Providence:

That Chapter 1994-52, No. 798, approved December 27, 1994 also known as *Providence 2000: The Comprehensive Plan*, (hereinafter referred to as "Plan") is hereby amended, pursuant to Rhode Island General Laws Sec. 45-22.2-12., as follows:

Section 1 — Proposed "Land Use Map: Residential" shall delete Medium Density Residential for that area on the east side of Broad Street, from Potters Avenue to Oxford Street, one lot deep.

Section 2 — Proposed “Land Use Map: Non-Residential” by inserting Limited Commercial for that area on the east side of Broad Street, from Potters Avenue to Oxford Street, one lot deep.

Section 3 — This Ordinance shall take effect upon passage.

PERSONAL EXPRESSION

COUNCILMAN DELUCA requests to speak on a point of personal expression and states:

"I make reference to this editorial on September 2nd in the Providence Journal. I'm just going to read a small caption that pretty much describes what I've been saying all along. It's not the first time we spoke on bilingual education on a public forum. I'd like to take every opportunity I get. "Bilingual education has been very profitable for some people. Unfortunately, those people do not include the Spanish-speaking children bilingual education is intended to help. Years of research, statistical review and experience have made it clear beyond any doubt: Teaching Hispanic children in Spanish does not just needlessly delay their learning English; it injures their ability to get along in the broader community..." I've pretty much been saying the same thing ever since this bilingual stuff came up and I speak from experience. I was an immigrant at ten years old when I came to this country. I didn't know a word of English. The fact that there wasn't any bilingual education — didn't worry any different — Everybody in the neighborhood — didn't speak Spanish or every day you go around and you go into a store and somebody could speak Italian. It was a common thing. It's the same exact set of circumstances. — to learn English as soon as possible And they could progress through the social changes that happened to take place when you come from one country to another — eating

habits, talking habits — They have to adjust. There are many social adjustments to be made. The best thing is to get the kids right into the main stream of the school system and receive straight English. I attest to you that in three months — I could walk around the street and have a decent conversation in English. I wasn't fluent, but I could talk. When the mailman came to the door or a truant officer came to the door, for my brothers, not me, I could tell my parents what the problem was. Because the kids, and I swear to you, they can learn just like that. When your 17, 18 years old your tongue is already developed that language. You'll speak broken English — For the older people, my father was 74 when he died, he still didn't know how to speak English. Once you get to an age, you kind of hang around that group you grow up with and work with, you never end up learning. The kids — great help to their family and a great help to them to succeed in life. So, I hope that the subject on bilingual education is taken up with the School Board and that we go their and come up with a better kind of — Not only, I know it doesn't work, as the article reports, the money that's being spent isn't being spent on the children. We could utilize those points within the school system for good activities and better educational programs. I had to learn with cardboard and a little square with a picture of a turkey next to it and there was a box of little square papers, we had to find the word and put it under the puzzle. Maybe today, they can do a

little colored computer. wasting it on ineffective — Thank you."

COUNCILMAN LOMBARDI requests to speak on a point of personal expression and states:

"Two quick points. One of personal opinion, the first one of not so serious one and you know it's the court jester in me that brings this out. But, earlier this evening the Majority Leader was talking to me and she was confused as to whether or not . . . she was trying to make a very difficult decision and that was whether or not to go and sit on that side of the room or this side of the room. Well, let me say this, Madam President, and you certainly know as you, my esteemed colleague and John Rollins, along with myself, evidently she doesn't like the skunk cologne that I use. But finally once Councilwoman Romano got elected, I opted to sit in this sit because I wanted to sit near someone attractive. Well, low and behold, here's comes this young whipper snapper called Hassett and he stole her heart away. I can't get near her. So, I know where he's coming from. So, I'm after him, I'm declaring the war right now. But, more seriously, I heard one of the most ridiculous things today on the news and I just got to pass it on. You know that I'm a night owl. I just don't sleep at night, I wish I could and maybe I should because I let stupid things bother me. But, Joanie, that's what I've been trying to do, I've been trying to call you, but you don't want to hear it. Now, you're with Hassett character, your not getting the message. But, major credit card companies, their using a disincentive when you pay your credit cards on time. So, their penalizing you when

you pay your credit cards on time. It's just the most ridiculous thing. It's certainly makes sense, I mean from a business point of view. That is that their getting 17 to 21% on the interest. I mean what is that telling people, it's just the most ridiculous thing and it's certainly not the place for this esteemed body. But, you know, it kind of makes you wonder where this world is going sometimes that you even got to try and worry about that kind of thing. So, there's a disincentive for you to pay your credit cards on time. But, it doesn't take away from the major issue that Hassett is stealing DiRuzzo away from me. Thank you Madam President."

COUNCILMAN ALLEN requests to speak on a point of personal expression and states:

"Two issues I think are important. Just information for my colleague, a couple of months ago, we passed a resolution requesting the school department to do a complete air quality assessment of all the schools in the City of Providence and at that time, we were told by the Superintendent that would be done and there will be a report to us at the beginning of the school session. Well, it has not been done and it has not been done for a reason and I think it's important to note that the issue of air quality only becomes effective when the kids are in the schools. It doesn't make any sense to do air quality tests when the school is empty. Because the carbon dioxide that is given off by persons, the levels would not be what they are, if the kids are not there. So, I talked to Dr. Zarrella yesterday and he informed me that one week from yesterday, the Board of Contract and Supply will be getting a request to do the air quality test and he assured me that whatever the results are for any schools in the City of Providence, any thing that has to be corrected, will be corrected before the windows are shut and the heat comes on for the winter season. In addition to that, Gilbert Stuart, which was the school that kind of participated this whole issue, he's assured me that as we speak the

ventilation system is being fabricated and again before the winter sets in they will be installed and that the children will not have to be exposed to high level of carbon dioxide. I think Dr. Zarrella ought to be applauded for that because he clearly responded to the charge and took the necessary steps to try and correct the problems. The second issue, however, is today I spent the morning over at the two new schools. And quite frankly, I was not as pleased with the level of activity was going on there that I think should have been going on. For instance, along one side of the . . . there is still work going on in the schools. The kids are in there, workers are in there. The problems with trucks parked on the sidewalk along the side streets is still a problem. The crossing guards have not been increased. Painting of the crossing lines

have not been done as we were told they would be done within the next two weeks by the Finance Committee through Irene Testa. Some classrooms don't have desks. I have asked the office to setup a meeting with the School Department, the Police Department, Irene Testa, Alan Sepe to try and see how we can coordinate this effort to try and bring these schools into the condition that they should be in for our kids to learn. But, I would hope that all parties would be able to sit down in the next day and sit down and try and work out some arrangements so that the kids safety can be addressed, the kids educational needs can be addressed and the City issues can be addressed. Thank you."
