Gentlemen:

The Providence Redevelopment Agency, in accordance with the provisions of Chapter 1797 of the Ordinances of the City of Providence approved November 7, 1966 as amended by Chapter 1798 of the Ordinances of the City of Providence approved November 7, 1966 and Title 45, Chapters 31-33 of the General Laws of Rhode Island 1956, hereby reports concerning the proposed sale of real property within the East Side Renewal Project R. I. R-4.

1) The Agency proposes the sale of Parcel 109 and 109A consisting of 38,659 sq. ft. of land as delineated on the attached map for the disposition price of \$43,700 to Fox Point Associates of Providence, Rhode Island for residential construction for the elderly in accordance with plans approved by the Agency.

Also, the Providence Redevelopment Agency, in accordance with the provisions of Chapter 1972-42 of the Ordinances of the City of Providence, approved September 11, 1972, as amended by Chapter 1974-29 of the Ordinances of the City of Providence approved September 28, 1972, and Title 45, Chapters 31-33 of the General Laws of Rhode Island 1956, hereby reports concerning the proposed sale of real property within the Comstock Redevelopment Project.

1) The Agency proposed the sale of Parcel 2 consisting of 6,631.2 sq. ft. of land as delineated on the attached map for the disposition price of \$995 to Rosie Lee Frisby of 249 Public Street, Providence, Rhode Island for residential construction.

2) The Agency proposes the sale of Parcel 19 consisting of 5,623.0 sq. ft. of land as delineated on the attached map for the disposition price of \$560. to Cora E. Rose of 116 Corinth Street, Providence, Rhode Island for residential construction.

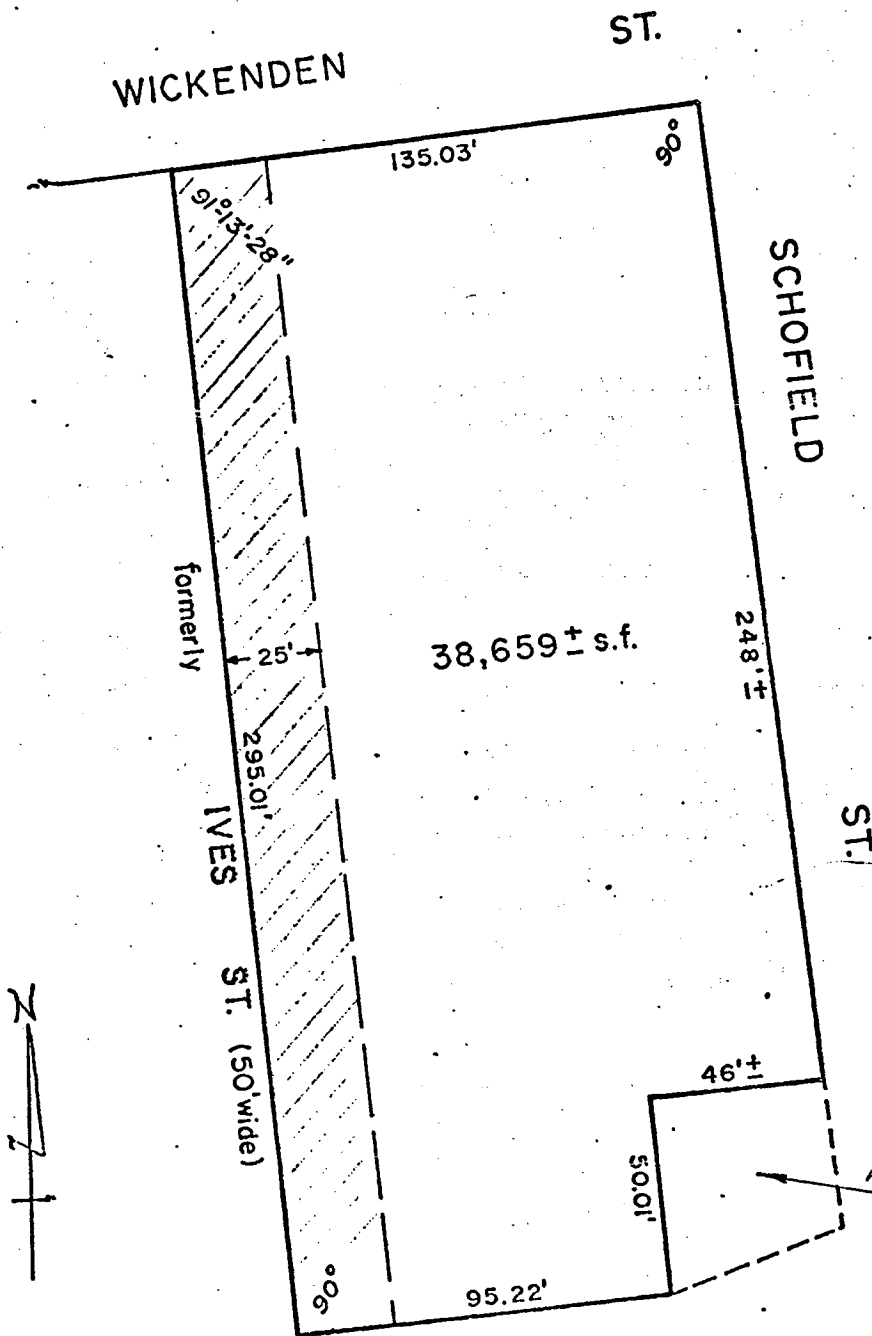

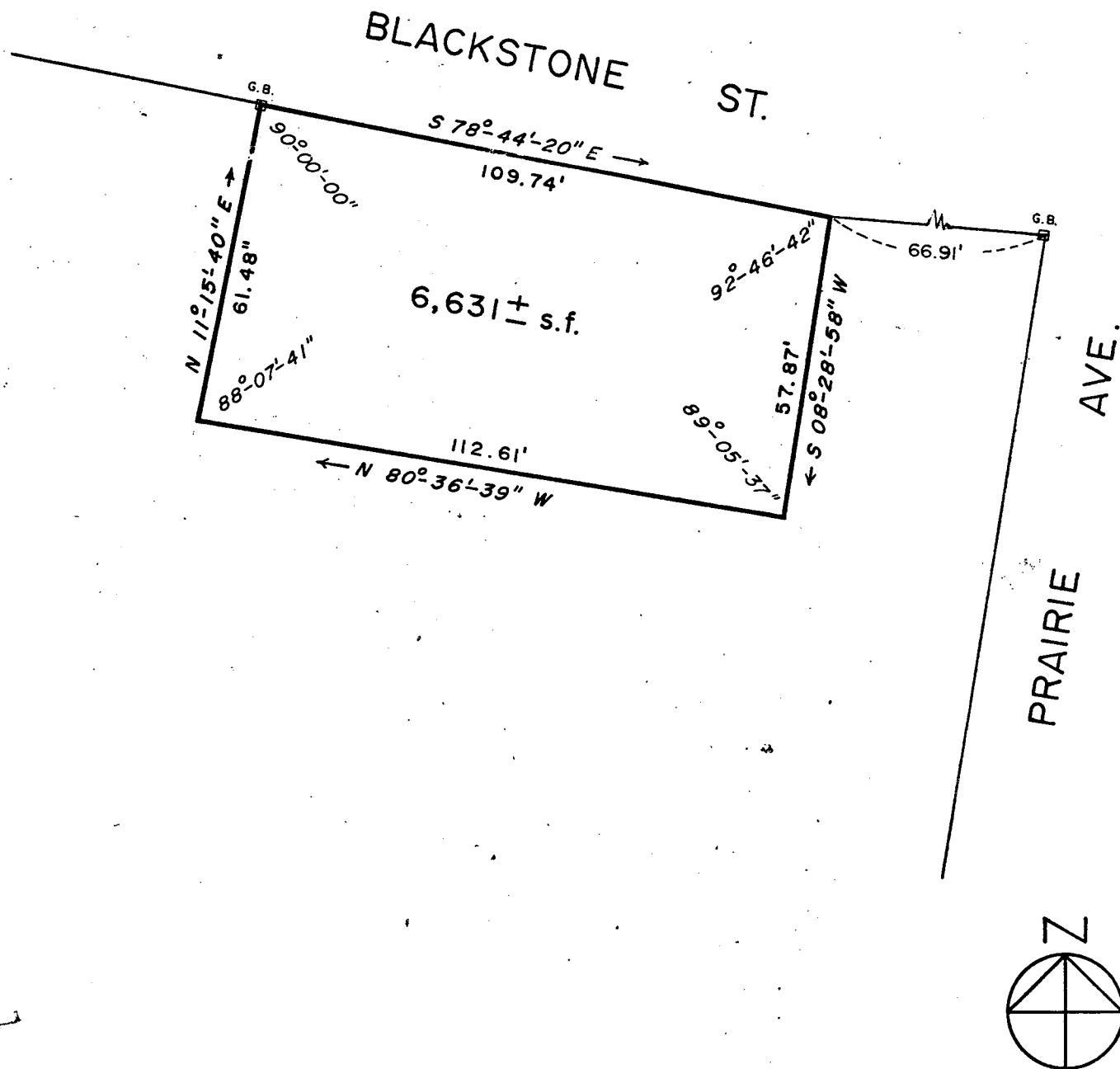
Interstate Route - 195 State Highway Plat 1379

COMSTOCK RENEWAL PROJECT

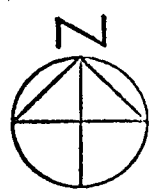
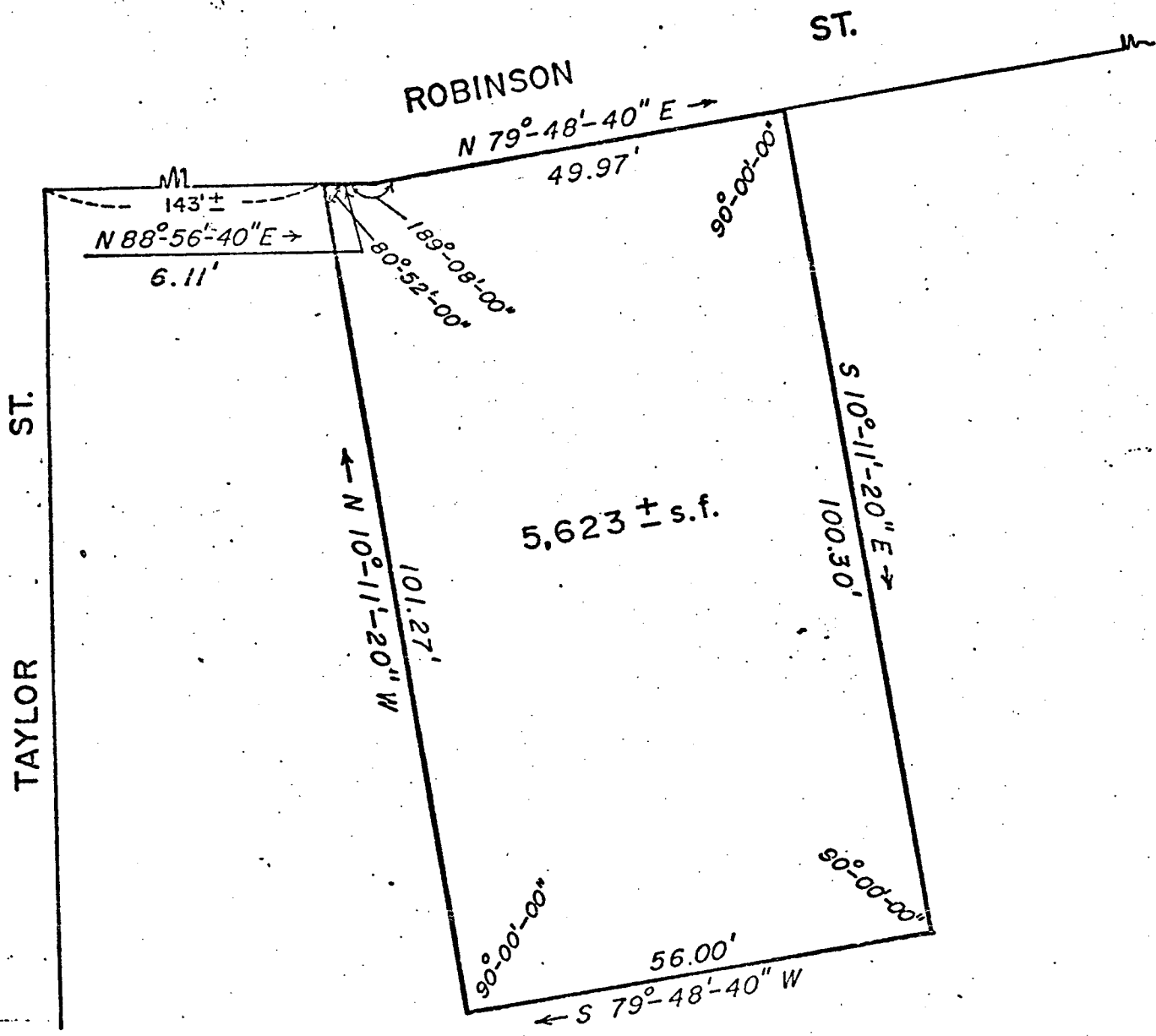
