REPORTS FROM COMMITTEES

COUNCILWOMAN CAROLYN F. BRASSIL, Chairwoman COMMITTEE ON FINANCE

Transmits the following with Recommendation, the Same be Severally Sent Back to His Honor the Mayor:

An Ordinance Making an Appropriation of One Hundred Thirty-Nine Million, Three Hundred Sixty-Five Thousand, Seven Hundred Seventy-Five Dollars and Twenty-Three Cents (\$139,365,775.23) for the Support of the City Government for the Fiscal Year ending June 30, 1981.

An Ordinance Establishing the Classes of Positions the Maximum Number of Employees and the Number of Employees in Certain Classes in the City Departments and Repealing Ordinance Chapter 1979-32, Approved June 22, 1979, and All Amendments Thereto.

An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Chapter 1979-31, Approved June 22, 1979, and All Amendments Thereto.

An Ordinance Providing for the Assessment and Collection of 1980 Taxes in a Sum Not less than Seventy-Five Million, Eight Hundred Thou-

sand Dollars (\$75,800,000.00) and Not More than Seventy-Seven Million, Four Hundred Thousand Dollars (\$77,400,000.00) being based on One Hundred Percent (100%) of the 1980-1981 Fiscal Year Tax Collection as Amended.

On motion of COUNCILMAN ADDISON, seconded by COUNCILMAN GLAVIN, it is voted to transmit the Ordinances back to His Honor the Mayor.

COUNCILMAN PEARLMAN raises a point of order, at which time he cites Sections 6.23, 6.24 and 6.25 of the Charter of the City of Providence.

COUNCILMAN PEARLMAN requests a ruling from the DEPUTY CITY SOLICITOR on the propriety as to whether or not the City Council can send the Budget back to the Mayor, it being his understanding the Council has no authority except to amend it or disapprove it.

COUNCILWOMAN BRASSIL requests the floor to speak on Personal Privilege, stating she has been attacked from the floor as Chairperson of the Finance Committee and the Finance Committee has also been attacked from the floor.

Therefore, she is of the opinion that she should be granted the right for rebuttle on Personal Privilege.

COUNCIL PRESIDENT FARGNOLI requests a ruling from the DEPUTY CITY SOLICITOR.

DEPUTY CITY SOLICITOR ROTONDI questions as to who attacked COUNCILWOMAN BRASSIL.

COUNCILWOMAN BRASSIL states COUNCILMAN MANSOLILLO has suggested the Finance Committee resign their positions as Members of the Finance Committee.

RECESS

COUNCIL PRESIDENT FARGNOLI declares the City Council Stand at Ease at 6:20 o'clock P.M. (E.D.T.).

RECONVENTION

COUNCIL PRESIDENT FARGNOLI Recovers the City Council at 6:30 o'clock P.M. (E.D.T.) and directs the Clerk to Call the Roll to Ascertain if there is a Quorum Present:

DEPUTY CITY SOLICITOR ROTONDI states in accordance with Robert's Rules of Order a Member of the Council may not speak unless they are being attacked.

He states she can rebut the statement made against her performance as a Member of the Finance Committee but must contain her comments within those guidelines.

PERSONAL PRIVILEGE

COUNCILWOMAN BRASSIL requests
and is now granted the Privilege of the
Floor and states:

"Mr. President, Fellow Members, I feel my Committee has done as good a job as it is possible with this Budget as presented to us. Unfortunately, we've lost the ball somewhere along the line. The Mayor is charged with coming in with a balanced Budget by our own Charter. That has not happened and to put the onus on the Finance Committee for not doing their duty is absolutely a dishonest statement and I stand to defend the Finance Committee. The Mayor is the one that is charged with getting to us a balanced Budget by the Charter and every one of you here know that and to stand up and say "We didn't do our job," the Mayor has not done his job and until he does he shouldn't submit that Budget to us."

COUNCIL PRESIDENT FARNGOLI now requests a ruling on **COUNCILMAN PEARLMAN'S** Point of Order as to the propriety of sending the Ordinances back to the Mayor.

DEPUTY CITY SOLICITOR ROTONDI informs the Council the Mayor submits the Budget and it is the responsibility of the Members to increase, decrease, alter or strike; therefore, it is his opinion, in reviewing the City Charter, there is no authority to send the Budget back to the Mayor.

COUNCIL PRESIDENT FARNGOLI rules

the **DEPUTY CITY SOLICITOR'S** opinion is out of order and the motion to transmit the Several Ordinances Back to the Mayor is now in order and requests the Clerk to read the motion.

The Clerk reads the motion made by **COUNCILMAN ADDISON**, seconded by **COUNCILMAN GLAVIN** to transmit the Ordinances Back to His Honor the Mayor.

The Roll being called and votes cast as follows:

Ayes: Council President Farnnoli and Councilmen Addison, Boyle, Councilwoman Brassil, Councilmen Dillon, Easton, Glavin, Johnson, Lynch, Moise, O'Connor, Paolino, Petrosinelli, Salvatore and Stravato—15.

Noes: Councilmen Almagno, Cola, Farmer, Griffin, Mansollillo, Pearlman, Pennine and Snowden—8.

Absent: Councilmen Cirelli, Flynn and Xavier—3.

The motion for Transmittal Back to His Honor the Mayor is Sustained.
