Be it ordained by the City of Providence:

SECTION 1. Chapter 1489, of the Ordinances of the City of Providence, as approved September 21, 1962 entitled: "An Ordinance Making Appropriation of \$43,334,668.75 for the Support of the City Government for the Fiscal Year Ending September 30, 1963", as amended, is hereby further amended by appropriating the sum of One Hundred Twenty-Five Thousand (\$125,000) Dollars to PUBLIC WORKS DEPARTMENT - SEWER CONSTRUCTION and MAINTENANCE DIVISION, ITEM 7.

SECTION 2. The said sum of One Hundred Twenty-Five Thousand (\$125,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by One Hundred Twenty-Five Thousand (\$125,000) Dollars.

SECTION 4. The City Controller and the City Treasurer are hereby authorized and directed to transfer this appropriation from the General Fund to an account in the Capital Funds to be known as, "SEWER CONSTRUCTION ACCOUNT". Any unexpended balance remaining in this account upon completion of this work shall revert to the General Fund.

SECTION 5. This ordinance shall take effect upon its passage.



AMENDATORY GRANT OFFER

This Amendatory Grant Offer by and between the City of Providence (herein called the "Applicant") and the Housing and Home Finance Agency, hereinafter referred to as the Government, WITNESSETH:

WHEREAS, the Grant Offer, dated January 31, 1963, and the Acceptance dated February 8, 1963, between the parties hereto, provided that, subject to the terms and conditions thereof, that the Government would make a grant of not to exceed \$110,000 in order to aid in financing the construction of essential public works or facilities estimated to cost \$220,000; and

WHEREAS, the estimated cost of the public works and facilities has decreased from \$220,000 to \$130,000; and

WHEREAS, the Applicant and the Government have agreed to a reduction in the amount of the grant from \$110,000 to \$65,000; and

WHEREAS, the Applicant and the Government are desirous of amending the Grant Agreement as hereinafter set forth;

NOW, THEREFORE, for and in consideration of the mutual benefits flowing to the Applicant and the Government, the aforesaid Grant Offer is hereby amended as follows:

1. In line 4, change "~~\$110,000~~" to "\$65,000".
2. In line 8, change "\$220,000" to "\$130,000".
3. In line 11, change "\$220,000" to "\$130,000".
4. Delete Section 26, Surety, of the Terms and Conditions in its entirety.

All the provisions, terms and conditions of the Grant Agreement shall remain in full force except as amended hereby.

WHEREAS, on May 16th, 1963, Councilman Charles A. Kilvert and Thomas W. Pearlman of the Second Ward of the City of Providence presented a Resolution calling for a bi-partisan full and impartial investigation of the alleged payroll irregularities by Municipal employees, and,

WHEREAS, said Resolution was referred to the Public Welfare Committee of the City Council at said time by voice vote over the objection of the sponsors, and

WHEREAS, this matter deserves immediate and prompt attention before records are lost, mislaid or destroyed, witnesses move or die and while information is fresh, and,

WHEREAS, the Public Welfare Committee of the Providence City Council has not acted on this Resolution and based on information and belief, seldom if ever meets, and,

WHEREAS, many citizens of the City of Providence demand and have a right to full and public answers to serious questions concerning alleged payroll irregularities; For example:

- (1)...How can a non-existent person be on the City payroll since 1949?
- (2)...How could the Mayor and City Administration in its annual budget request funds for the weekly payroll of non-existent employees year after year since 1949?
- (3)...How could the City Council approve these budgets every year without discovering such an abuse, and

WHEREAS, it is the role and duty of the members of the City Council to leave no stone unturned and cause a full, and impartial investigation of any alleged irregularities and abuses, and

WHEREAS, the vast majority of the voters of every district, of every member of our City Council desire their City Councilmen to work for a full, public, and independent investigation of these irregularities, and

WHEREAS, the Mayor and the executive branch of the City Government cannot properly investigate itself and thereby attempt to become

judge, jury and accused, nor do such methods satisfy the citizens of Providence who will rightfully label such a study as a "white wash", and,

WHEREAS, the three member study committee set up by the Mayor has no authority to subpoena witnesses and records and is primarily if not solely concerned with improvement of payroll procedures, but not the past and present irregularities in all City Departments, and,

WHEREAS, the Police department has limited its investigation of abuses to only specific irregularities of the Public Works department of a criminal nature, but not matters of City employees who are not doing a full day's work for a days pay, and

WHEREAS, there is no reason to believe that such irregularities do not exist in other City Departments since they have been found in one department and continued without interruption since 1949, and,

WHEREAS, the so-called Kilvert-Pearlman resolution (which provides for (5) five members including a councilman of each party, a Rhode Island banker, a certified public accountant and a representative of Rhode Island Public Expenditures Council) would permit a complete and impartial investigation of all possible irregularities, and


WHEREAS, such a committee could and should conduct its investigation without interfering with the right to a fair trial of City employees not facing criminal charges, any more than the investigation to uncover other members of a smuggling-ring would interfere with rights to a fair trial of one member who may be under indictment, and,

WHEREAS, the City Administration should welcome a full impartial and complete investigation if there are no other such irregularities in order to vindicate themselves.

Now therefore be it Resolved:

- (1)...That the City Council, by majority vote of all its members present under Rule 23 of the City Council, discharge the Public Welfare Committee from further consideration of aforesaid Resolution which had been referred to said Committee on May 16, 1963, and
- (2)...That the City Council take immediate action and approve said Resolution.


