
Gentlemen:

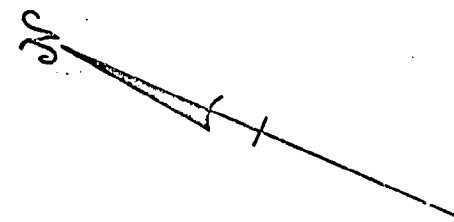
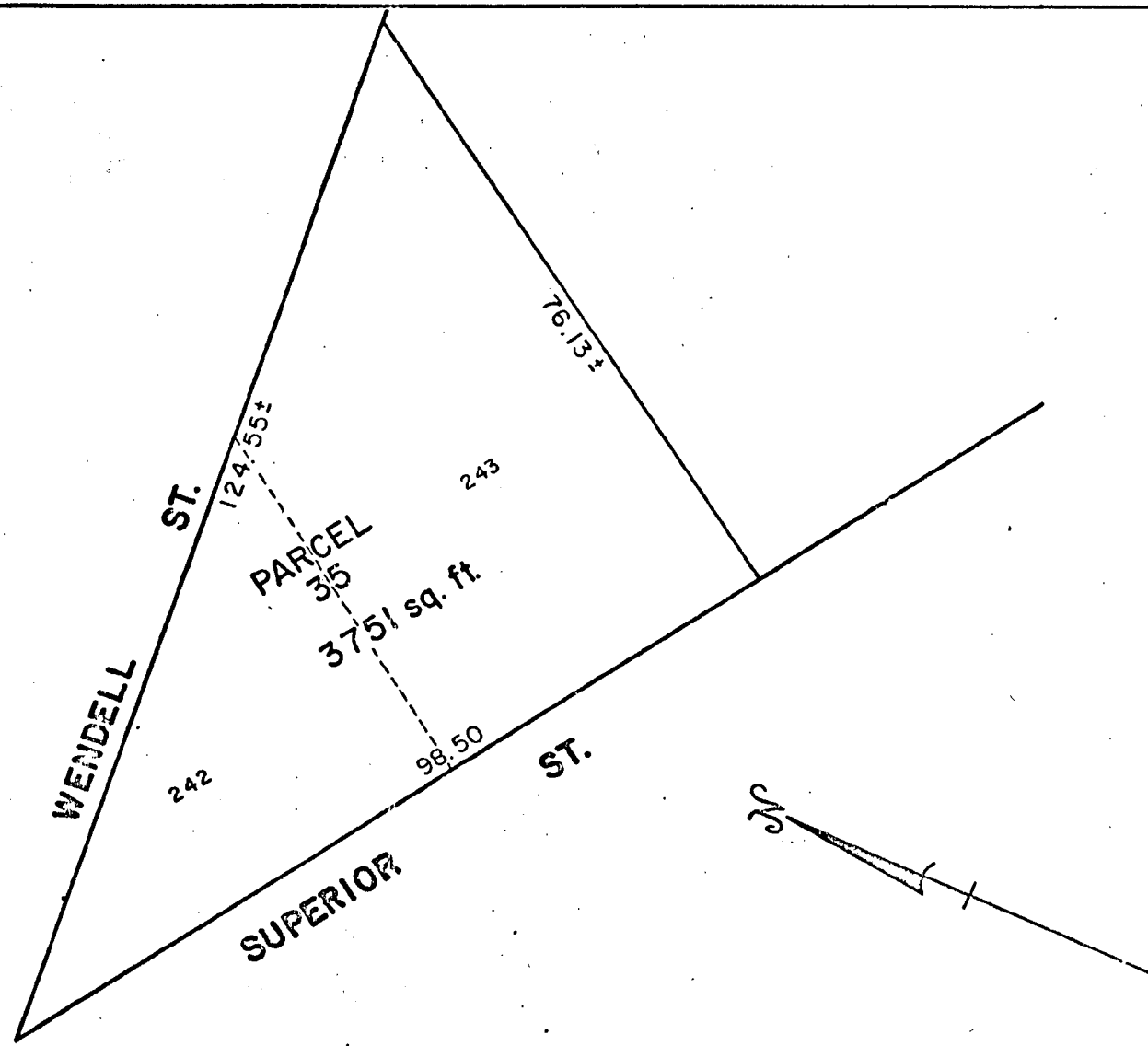
