CLASS TITLE: Administrative Assistant and Deputy Registrar of Vital Statistics.

CLASS DEFINITION: Responsible administrative work relating to management functions of the department as distinguished from those of a strictly medical nature.

DISTINGUISHING FEATURES OF WORK: Work involves responsibility for directing and supervising the fiscal and business management operations of the department, for planning and developing management methods and procedures, for supervision of personnel and personnel practices. Said responsibilities include, but are not restricted to the functions of the Bureau of Vital Statistics.

ILLUSTRATIVE EXAMPLES OF WORK: Maintains or supervises the maintenance of records relating to payrolls, supplies and services. Assists in the exercise of budgetary controls and budget preparation. Supervise personnel and records related thereto. Oversees the collections and dissemination of all information concerned with vital statistics. Prepares studies and recommendations for improved methods and precedures. Performs related assignments as required.

DESIRABLE KNOWLEDGES, SKILLS AND ABILITIES: Knowledge of the principles and methods of management, of budgetary and cost procedures, and familiarity with personnel procedures. Skill in developing cooperative and harmonious working relationships within the department. Ability to plan, develop and supervise the execution of approved department policies.

QUALIFICATIONS REQUIRED FOR APPOINTMENT: Graduation from a standard high school. Previous experience of a responsible nature in private or public employment.

HOUSING STANDARDS DIVISION, ITEM 0-\$6,685; ITEM 1-\$660.00.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1350 of the Ordinances of the City of Providence as approved September 16, 1960 entitled: "An Ordinance Making Appropriation of \$40,869,634.16 for the Support of the City Government for the Fiscal Year Ending September 30, 1961", as amended, is hereby further amended, by appropriating the following sums to the MINIMUM HOUSING STANDARDS DIVISION, ITEM 0-\$6,685; ITEM 1-\$660.00.

SECTION 2. The said sum of Seven Thousand Three Hundred Forty-Five (\$7,345) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures to the Receipt Account.

SECTION 3. The estimated receipts from Reserve for Extraordinary Expenditures are hereby increased by Seven Thousand Three Hundred Forty-Five (\$7,345) Dollars.
