



It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 45-13 of the General Laws entitled "State Aid" is hereby amended
2 by adding thereto the following section:

3 45-13-9.1. Reimbursement to cities and towns for general use of local open spaces. --
4 Any municipal park or open space that can document usage by nonresidents of that city or town
5 in excess of fifty percent (50%) shall be entitled to a state appropriation in an amount equal to
6 twenty-seven percent (27%) of the budget of said park including, but not limited to, capital
7 improvements, operations and maintenance. Said funds must only be utilized for capital
8 improvements and operations for the municipal park or open space.

9 SECTION 2. This act shall take effect upon passage.
