(c) Distance from schools. No license for either an amusement center or a mechanical amusement device shall be issued to any premises, any point of which is within 1,200 feet of any point on the property of any school, public or private, unless said license provides that said center or device may not be operated until 4 p.m. on days in which any school within said 1,200 foot area is in session; provided, however, that any establishment having a B, C, D, or J Liquor License issued by the Bureau of Licenses shall not be subject to this sub-section.
