

RESOLUTION OF THE CITY COUNCIL

Approved May 2, 1973

RESOLVED, DECREED, AND ORDERED,

That the Director of Public Works cause the construction of a main drain or common sewer starting at a point at the termination of the present sewer line in Belmont Avenue, thence for a distance of thirty-four (34') feet more or less in a southwesterly direction to a point in Claremont Avenue, thence southerly for a distance of ninety-five (95') feet more or less and also from that point at the termination of the present sewer line in Belmont Avenue, thence for a distance of thirty-four (34') feet more or less in a northwesterly direction to a point in Claremont Avenue, thence northerly for a distance of sixty (60') feet more or less, and

BE IT FURTHER RESOLVED,

That the petitioning corporation, being C.I.R. Enterprises, Inc., of Johnston, Rhode Island, be assessed any and all sewer installation charges which would normally be assessed to abutting real estate owners.


Dear Chairman Payne:
