No. 296 AN ORDINANCE

An Ordinance in Amendment of and in Addition to Chapter 1575 of the Ordinance of the City of Providence entitled "An Ordinance approving and adopting the Official Redevelopment Plan of the Weybosset Hill Project No. R.I. R-7".

Approved June 11, 1973

Be it ordained by the City of Providence:

1. That Chapter 1575 of the Ordinance of the City of Providence, entitled "An Ordinance approving and adopting the Official Redevelopment Plan for the Weybosset Hill Project No. R.I. R-7" as heretofore amended, be and is hereby further amended as follows:
 - A. Certain Maps of the aforementioned Official Plan hereinafter identified are deleted:
 - (1) Map No. 2 "Proposed Land Use and Zoning" dated 9-19-72 at Page 45;
 - (2) Map No. 4 "Right-Of-Way Adjustments" dated 9-19-72 at Page 47;Insert the following Maps in their stead:
 - (1) Map No. 2 "Proposed Land Use and Zoning" revised 2-6-73 at Page 45;
 - (2) Map No. 4 "Right-of-Way Adjustments" revised 2-6-73 at Page 47.
2. That said Chapter 1575 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.
3. That this ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.

Transmitted herewith is a copy of a proposed ordinance providing for an amendment to the Official Redevelopment Plan for the Weybosset Hill Project.

The proposed ordinance deletes certain maps of the Redevelopment Plan and substitutes the attached maps in their stead. The revision was necessitated by a change in the existing right-of-way to be vacated to an existing right-of-way to remain. Essentially, a portion of Garden Street was to be abandoned, however, under the new proposal, that section of Garden Street from Greene Street to Jackson Street will remain.

It is respectfully requested that this matter be placed on the Docket for the City Council Meeting of March 15, 1973.
