Dear Mrs. Mendonca:

City Council Resolution No. 610, approved September 30, 1977, authorized the Mayor to prepare and submit an application under the Urban Mass Transportation Act of 1964, as amended (Section 3), to aid in the financing of the Kennedy Plaza Transit and Pedestrian Improvement Project.

The application for Section 3 fund totalled \$4,906,000 of which 80% or \$3,925,000 was the UMTA share, and 20% or \$981,000 was the City's share to be provided by the Providence Redevelopment Agency through an amendment to the Downtown Providence Renewal Project.


On September 21, 1978, UMTA notified the City that it had approved a project budget of \$425,720 for professional engineering and design services for the first and second quarter of fiscal '79, and that the governing body of the City must authorize contract execution to satisfy that requirement. The attached original and 10 copies of a proposed City Council resolution is presented for your approval.

It is noted that UMTA has established a time schedule for receipt of the executed contract documents, which would require placing the resolution before the City Council Docket on December 7, 1978 for referral to the City Council Committee on Urban Redevelopment, Renewal, and Planning, and for City Council passage of said resolution at its December 21, 1978 meeting.
