


This letter will constitute my resignation, effective immediately, from the Providence School Board. Obviously, this resignation is prompted only because I was recently elected Governor of Rhode Island, and am totally occupied in transition activities.

I am grateful for the opportunity of serving on the School Board, and feel that good progress was made during my tenure in the areas where I had some responsibility. For five years I served as Chairman of the budget sub-committee, and I am proud that we had three years of surplus and a surplus for the period. The variance from budget for the 5 years was only 1%. The Early Intervention Program which I supported with Superintendent Almagno helped lower the drop-out rate by 25%, and today's Providence Journal confirms that MAT scores have increased substantially, and above the national average.

It was an honor to also chair the search committees that selected Superintendent Almagno and more recently Superintendent Roberti, both highly qualified individuals with innovative programs. Thank you for the opportunity to serve on the Providence School Board. To be involved with the education of elementary and secondary students is a very important and satisfying public service.
