A G R E E M E N T

WHEREAS the RHODE ISLAND WHOLESALE GROCERY COMPANY, a Rhode Island corporation, owns a large area of land under water known as DYERVILLE POND, west of Manton Avenue in the City of Providence, and

WHEREAS the City Council of the City of Providence desires to operate a controlled dump on a portion of said premises for the convenience of the inhabitants of the City of Providence and the disposal of the city's waste,

NOW, THEREFORE, This Agreement made and concluded this day of AUGUST, A. D. 1957 by and between the CITY OF PROVIDENCE, a municipal corporation created by the General Assembly of the State of Rhode Island, hereinafter called the "CITY" and RHODE ISLAND WHOLESALE GROCERY COMPANY, a corporation organized under the laws of the State of Rhode Island, hereinafter called the "COMPANY".

W I T N E S S E T H:

In consideration of the premises and agreements herein mutually entered into, the parties agree for themselves, their successors and assigns as follows:

1. That the City shall have the right to dump into and fill that certain tract or parcel of land situated generally west of Manton Avenue in the City of Providence, shown as shaded area and designated by the letters A-B-C-D-E-F-G-H-J-K-L-M on the accompanying plan entitled, "Providence, R. I., P. W. Dept.--Engineering Office, City Property Section, Plan No. 061600, Date July 22, 1957", bounded and described as follows:

Beginning at the northwesterly corner of Lot 314 as shown on Assessor's Plat 34, said point being marked "A" on the accompanying plan; thence in a general southerly direction and bounding generally easterly in part on other land of this grantee and in part on land now or formerly of William F. McGowan and wife, Anna A. to the northwesterly corner of Lot 190, said point being marked "H" on the accompanying plan; thence westerly in range of the northerly line of said Lot 190 and bounding southerly on other land of this grantor to point marked "J" on said plan; thence in a general northerly direction in a line sixty (60) feet easterly from and parallel with the westerly shore line of the Neemasquatucket River to point marked "K" on said plan; thence northerly to point marked "L" on said plan, said point being on the general southerly line of Lot 194, one hundred thirty (130) feet, more or less, from the northwesterly corner of said Lot 194; thence in a general easterly direction along the shore line of Dyerville Pond, so called, and bounding generally northerly on land now or formerly of James Apice and wife Rose to point marked "M" on said plan, this last described line being also the general southerly line of Lot 194 on said plan; thence southerly and bounding easterly in part on land now or formerly of Peter Amore and in part on land now or formerly of Joseph Starano to the northwesterly corner of Lot 314 and the point and place of beginning and containing 562,400 square feet, more or less.

Said parcel is further identified as being a portion of Lot 234 on Assessor's Plat 34.

2. This dump shall be operated by the City of Providence under the control of the Director of Public Works of said City during the period of operations and when said dumping operations are completed the surface will be covered with soil.
3. The City will repay the company for any increase in taxes paid, over and above the normal increase of assessments on adjacent land in the area, until such time as the land is actually put to productive use.
4. The City will convey to the Company for purposes of ingress and egress a strip of land fronting approximately fifty (50) feet on Nanton Avenue, and holding that width extending back to the property of the Company, so that when dumping operations are completed the land on which operations have taken place will have access to Nanton Avenue as said Avenue then exists.

IN WITNESS WHEREOF, the parties have signed and executed these presents, the CITY OF PROVIDENCE by WALTER H. RICHMOND, the Mayor hereof, herunto duly authorized by Resolution No. _____ and RHODE ISLAND WHOLESALE GROCERY COMPANY, by its duly authorized officer.

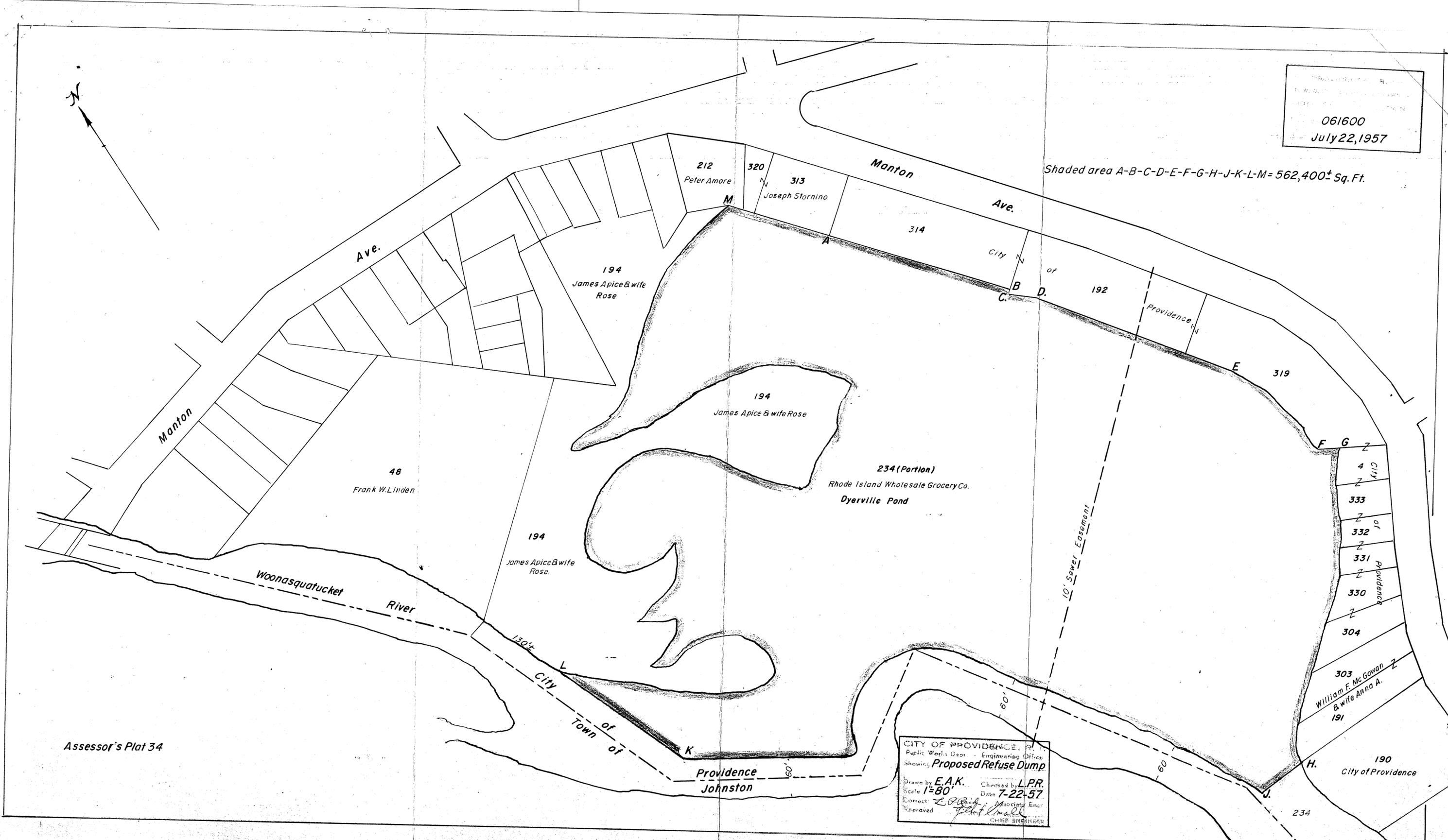
