## ORDINANCES SECOND READING

An Ordinance Amending the Appropriation Ordinance Chapter 1986-30 Approved June 26, 1986 by Transferring Various Sums of Money within Various Departments, as Amended.

*Be it ordained by the City of Providence:*

*Section 1.* Chapter 1986-30 of the Ordinances of the City of Providence as approved June 26, 1986, entitled: "An Ordinance making appropriation of One Hundred Eighty Eight Million, Two Hundred Nine Thousand, Twenty Four Dollars and Seventy Two Cents (\$188,209,024.72) for the Fiscal Year ending June 30, 1987, as amended", is hereby further amended by transferring various sums of money within various departments. *Section 2.* This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of Sections 48 and 63 of Chapter 1986-31 as Approved June 26, 1986, Entitled: "An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain Classes in City Departments", Relative to Various Departments.

*Be it ordained by the City of Providence:*

*Section 1.* Sections 48 and 63 of Chapter 1986-31, of the Ordinances of the City of Providence, as approved June 24, 1986, as amended, is hereby further amended as follows:

Sec. 48. The number of employees in the Department of Public Programming Service — Park shall not exceed seven (7). There shall be no more than:

*Add*

- (1) Coordinator of Special Projects
- (1) Director of the Museum of Natural History

Sec. 63. The number of employees in the Department of Human Services shall not exceed two (2). There shall be no more than:

*Add*

- (1) Director of Human Services
- (1) Director of Senior Affairs

Section 2. This ordinance shall take effect retroactively to July 1, 1986.

An Ordinance in Amendment of and in Addition to Article III of Chapter 12 of the Code of Ordinances of the City of Providence Entitled, "Garbage Trash and Refuse" as Amended.

*Be it ordained by the City of Providence:*

Section 1. Article III of Chapter 12 of the Code of Ordinances of the City of Providence is hereby amended by adding subsection (e) to Sec. 12-4 6. Subsection (e) shall read as follows:

"(e) *Dumpster*. "Dumpster" shall mean any bulk container with a capacity greater than one (1) cubic yard constructed and placed for use as a depository for refuse, trash or garbage."

Section 2. Article III of Chapter 12 of the Code of Ordinances of the City of Providence is hereby further amended by adding thereto Sec. 12-61.1, which shall read as follows:

*Sec. 12-161.1. Use of dumpsters.*

(a) *Permit required*. Any person, prior to placing a dumpster on public property for any period of time, shall first obtain a permit from the Director of Public Works. Said permit shall specify the size and location of the dumpster and the length of time that said dumpster may be used on the said public property.

(b) *Minimum Standards*. Any dumpster used in the city shall meet the following standards:

(1) The dumpster shall be painted so as to be reasonably resistant to rust and corrosion.

(2) The name and telephone number of the dumpster owner shall be clearly painted on at least two sides of the dumpster.

(3) Dumpsters less than twenty (20) cubic yards in size shall be capable of being closed on all sides, except when opened for deposit or servicing.

(4) Dumpsters greater than twenty (20) cubic yards in size shall be capable of being secured so

An Ordinance in Amendment of Chapter 1986-32, Approved June 26, 1986, Entitled "An Ordinance Establishing a Compensation Plan for the City of Providence" Relative to Various City Departments.

*Be it ordained by the City of Providence:*

Section 1. Chapter 1986-32 of the Ordinances of the City of Providence is hereby amended to read as follows:

Section 2. This ordinance shall take effect retroactively to July 1, 1986.

as to prevent the spillage of refuse, waste or garbage from the container.

(5) No dumpster located within 200 hundred ft. of a residential zone property shall be serviced between the hours of 11:00 o'clock P.M. and 5:00 o'clock A.M.

(c) *Use.* Any dumpster used in the city shall be maintained and serviced with a frequency sufficient to prevent spillage from overflow, to prevent the buildup of offensive odors, and to prevent a public hazard. The responsibility for the maintenance and servicing of dumpsters shall rest with the user or renter of the dumpster. The maintenance of dumpsters shall include the cleanup and removal of all litter thrown or left on the dumpster premises to prevent litter from drifting or blowing on to adjacent premises.

(d) *Illumination or Reflectorization of Trash Containers.* All commercial garbage and/or trash containers or dumpsters so-called located within the City of Providence on any part or portion of the public right-of-way, that is, sidewalk, pedestrian footpath, or roadway shall be illuminated with flashing beacon lights affixed thereto or in the absence of beacons, sheeted/afixed with high intensity reflectorized orange and silver construction work-zone sheeting pursuant to regulations specified by the Traffic Engineer, City of Providence.

All dumpsters shall be illuminated or reflectorized twenty-four hours daily.

The Traffic Engineer shall cause to be printed and have available for inspection and distribution the aforesaid regulations concerning specifications for beacon illumination or sheeting reflectorization.

(e) *Violations and Penalties.* Any person who shall violate any provision of this section, or any provision of any rule or regulation adopted pursuant to authority granted by this section, shall upon conviction, be punished as provided in Section 1-20 of this Code of Ordinances.

(f) *Enforcement.* The provisions of this section shall be enforced by the Director of Public Works."

Section 3. This Ordinance shall take effect upon its passage.

An Ordinance Re-establishing the Escrow Account within the Division of Minimum Housing to allow the Director to Accept rental payments to defray the costs of making repairs where serious hazards are found in violation of the minimum standards housing Ordinance, as Amended.

*Be it ordained by the City of Providence:*

Section 1. Section 40 of Chapter 13 of the Ordinance of the City of Providence is hereby amended to read as follows:

Sec. 13-40. Authority of director to make repairs and recover expenses.

Whenever any violation of this chapter which in the opinion of the director causes a direct hazard or immediate peril to the health, safety or welfare of the occupants of a dwelling or structure or of the public has not been corrected in the time specified by the immediate compliance order, he may, subject to the provisions of section 13-70 of this chapter, take such direct action as it is necessary to alleviate the violation causing the direct hazard or immediate peril — if the cost of such action is reasonably related to the value of the dwelling or structure. For the purpose of this section any repair, alteration or securing that is determined by the director to cost fifty per cent (50%) or less of the assessed valuation of the dwelling or structure shall be deemed to be reasonable. When certified by the director, the costs incurred in the execution of the immediate compliance order shall be paid out of the city treasury — or from other funds made available for such purposes to the director. The owner,

operator or occupant of the dwelling, dwelling unit, structure, rooming unit or dwelling premises who is responsible for immediate compliance shall be served a notice stating the amount of the expenses incurred by the director in executing the immediate compliance order. Such notice shall be served in the manner provided in section 13-37 of this chapter. These expenses shall be paid for by the responsible person or whom the notice is served and unless the expenses are paid within thirty (30) days after such notice is served, or unless repaid under section 13-48 of this chapter. In every case, certified expenses shall be the costs necessary to perform the required work as expeditiously as possible, together with a ten per cent (10%) service charge in addition thereto. The expenses incurred by the director shall constitute a lien against the real property and such liens shall be enforced in the manner provided or authorized by law for the enforcement of common law liens on personal property. Such liens shall be recorded and shall incur legal interest from the date of recording.

*Section 2.* Section 102 of Chapter 13 of the Code of Ordinances of the City of Providence is hereby repealed.

*Section 3.* Section 48 is added to chapter 13 of the Code of Ordinances of the City of Providence to read as follows:

(a) Notwithstanding any lease or other agreement between owner and occupant, if the director shall have ordered the repair, alteration or improvement of a dwelling under the provisions of section 13-39 in that he has given notice that the same constitute a direct or serious hazard or immediate peril to the health, safety or welfare of the occupants, then the obligations of paying the rent therefor to the owner may, in the discretion of the director, be suspended and the occupant be required to pay the rent into an escrow account established and operated by the City of Providence. Rent monies paid into the escrow account may be used by the director to defray the cost of correcting the conditions constituting a direct and serious hazard or

immediate peril to the occupants including but not limited to loss of necessary utilities, loss of heat between October 1 and May 1, gas leaks, serious plumbing or sanitation defects, serious infestation of rodents, or any condition creating a fire hazard or imminent danger to the health, safety or welfare of the occupants. When the director has taken direct action under the authority of section 13-40, and the obligations of paying rent to the owner has suspended, the occupant shall pay rent into said escrow account until the cost necessary to perform the required work is repaid.

(b) No action shall be maintained by the owner against the occupant for such rent which is paid into the above created escrow account, nor shall any action be maintained by the owner for possession of said premises if the occupant follows the provisions of this action.

(c) Rental payments paid into said escrow account in excess of those necessary to make repairs shall be paid to the owner on completion of the repairs as determined by the director. As each rental period is completed the occupant shall pay into said escrow account the amount of the rent then due and if the occupant fails to make payment in accordance with the rental period of the director, then the owner may maintain an action for rent or possession subject to such defenses as the occupant may have under the lease or agreement for rental of the premises and subject to other provisions of law.

*Section 4.* This Ordinance shall take effect upon its passage.
