

Resolution Urging the School Board to lower the distance requirement for receiving a free school bus pass from a three-mile radius to a two-mile radius.

*WHEREAS*, In order to be eligible for a free student bus pass, Providence public high school students must live outside of a three-mile radius of their school; and

*WHEREAS*, Limiting bus passes to only those who live outside a three-mile radius places an undue burden on students, causing tardiness, absenteeism, and placing financial strain on many families; and

*WHEREAS*, Many students who are ineligible for school bus passes report walking for an hour or more each way just to get to and from their high school; and

*WHEREAS*, Without a school bus pass, taking RIPTA buses to school costs families up to \$5 per day per student; and

*WHEREAS*, A family with two children enrolled in high school taking RIPTA to and from school every day without a free school bus pass would spend \$1,800 per year on their children's transportation; and

*WHEREAS*, Providence's three-mile walking distance is the largest such requirement in Rhode Island; and

*WHEREAS*, According to Serve Rhode Island, no other public school system in New England requires that students live more than three miles away from their school to receive a bus pass; and

*WHEREAS*, Boston, Fall River, Hartford, and Worcester all use a two-mile radius requirement for school bus passes; and

*WHEREAS*, Providence sees a greater increase in daily absenteeism rates between the winter and non-winter seasons than any other Rhode Island public school district; and

**WHEREAS**, According to Serve Rhode Island, the average daily absenteeism rate in Providence last winter was more than double the absenteeism rate during the spring, whereas East Providence, Cumberland, Bristol-Warren, and West Warwick - which all have walk distances of two miles or less - saw an increase in winter absenteeism of only 1.91%; and

**WHEREAS**, According to Providence Student Union students cannot reasonably be expected to learn and perform at their best in the classroom if they must walk such long distances in winter weather before the school day has even begun.

**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council does hereby urge the Providence School Board to provide funding in its 2014-15 budget to expand subsidized transportation for high school students, including those who live between two and three miles from their school, and

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, That the Providence City Council does hereby urge the Providence School Board to look at other issues related to student transportation, including pedestrian access issues that may exist in addition to the issue of distance "as the crow flies"; and

**NOW, THEREFORE BE IT FURTHER RESOLVED**, That the Providence City Council requests that the Providence School Board consider all possible funding sources (including anticipated increases in State aid and reallocation of existing spending) to pay for the increased transportation service to high school students; and

**BE IT FURTHER RESOLVED**, That, upon passage, copies of this resolution be sent to the members of the Providence School Board.


