AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1983-30 APPROVED JULY 10, 1983, BY TRANSFERRING THE SUM OF FIVE-HUNDRED DOLLARS (\$500.00) FROM STRUCTURES AND ZONING (1-004-02-114) TO DEMOLITION OF ABANDONED PROPERTY (1-013-07-155) AS AMENDED.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1983-30 of the Ordinances of the City of Providence, as approved July 10, 1983, entitled: "An Ordinance making Appropriation of One Hundred Sixty-Nine Million, Seven Hundred Ninety-Six Thousand, Two Hundred Forty Dollars and Ninety-Six Cents (\$169,796,240.96) for the Fiscal Year ending June 30, 1983, as amended", is hereby further amended by transferring the sum of Five Hundred Dollars (\$500.00) from Structures and Zoning (1-004-02-114) to Demolition of Abandoned Property (1-013-07-155).

SECTION 2. This Ordinance shall take effect upon its passage.
