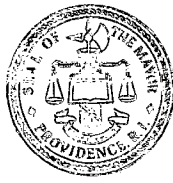



1 SECTION 1. Chapter 832 of the public laws of 1940 known as
2 the "Providence Charter Act of 1940", as amended, is further
3 amended by adding thereto the following section:

4 Section 186. The two members of the city council who sit on
5 the Dexter Donation Trust Fund Advisory Committee shall have the
6 power to vote.

7 SECTION 2. This act shall take effect upon passage.
