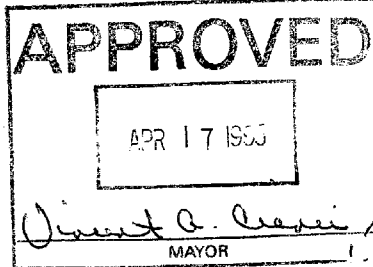

I would like to thank you for your invitation to join the festivities by naming a street, square, or park in Providence in Jerusalem's honor. This is an especially appropriate initiative as it will not only pay tribute to Jerusalem, but it will strengthen our common bonds as part of humankind.

In order for this initiative to come to its fruition it must undergo approval by the Providence City Council. I am forwarding a copy of your letter to Council President James Petrosinelli.

Throughout my tenure as mayor, I have demonstrated my solid commitment to meeting the needs of our Jewish residents. The City of Providence provided substantial funding to finance the design, construction, and installation of the Rhode Island Holocaust Memorial Museum. Additionally, through my leadership and initiative the City of Providence Retirement System has purchased a total of \$800,000 in State of Israel Bonds.


Dear Councilwoman DiRuzzo and Members of the Committee:

WHEREAS, 2nd Lt. Coleman received his training at Big Spring, Texas, receiving his commission as a second lieutenant, February 23, 1943, at Hondo, Texas, and

WHEREAS, 2nd Lt. Coleman, reported missing in action on January 4, 1944, and later reported killed in action over Germany; and

WHEREAS, The many friends and associates of this gallant bomber - navigator, decorated with the Air Medal and Oak Leaf Cluster, who paid the supreme sacrifice, desire to perpetuate the memory of this Providence born native;

NOW, THEREFORE, BE IT RESOLVED, That the intersection of Academy Avenue and Health Avenue be hereby designated as "Vincent B. Coleman Memorial Square".

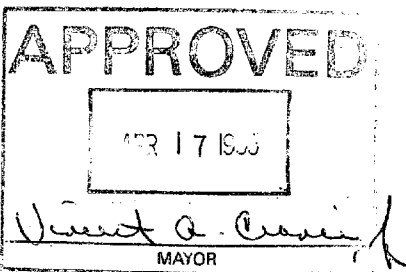

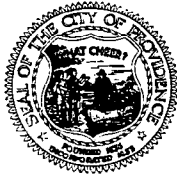

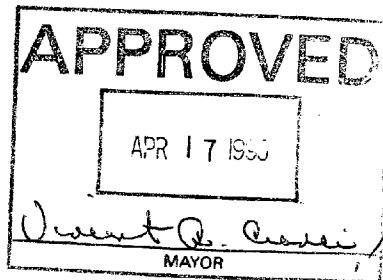
