Dear Councilwoman Williams:

At a regular meeting of the City Plan Commission on March 16, 2004, and pursuant to Section 1100 of the City of Providence Zoning Ordinance Chapter 1994-24, No. 365, as amended, the Commission reviewed a proposal for the above-captioned amendment to the Ordinance. The Commission voted unanimously as described below to make certain findings of fact and to recommend that the petition be approved.

Findings of Fact


Article XI of the Zoning Ordinance requires that in order for the CPC to make a positive recommendation on amendments to the Ordinance, it must demonstrate consistency with the Comprehensive Plan and with the purposes of zoning as listed in Section 100 of the Ordinance.

1. The amendment is consistent with the *Comprehensive Plan* in that this area of the City is designated "General Commercial" (C-2) uses.
2. The amendment is consistent with the purposes of zoning as listed in Section 100 of the Ordinance.

Recommendation

The CPC recommends to the Committee on Ordinances that the requested zone change be approved.

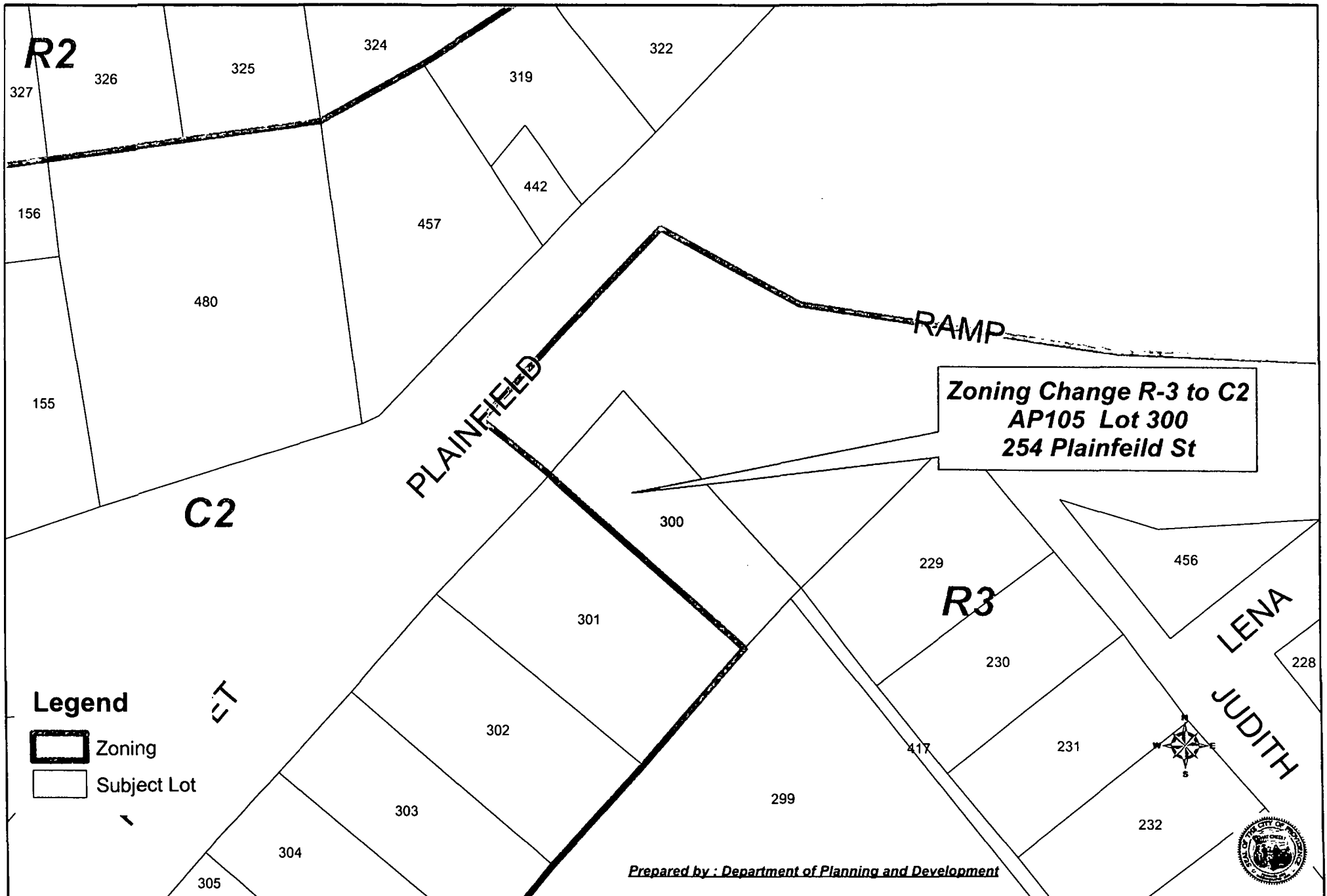
