RESOLUTION OF THE CITY COUNCIL

Approved November 8, 2004

WHEREAS, Rhode Island Food Bank is an organization incorporated under the not for profits statutes of another state or the District of Columbia, and

WHEREAS, Rhode Island Food Bank, on or about March 21, 2002, purchased the real estate located at 170 Niantic Avenue, in the City of Providence, and

WHEREAS, said property is to be used to further the purposes of Rhode Island Food Bank, and

WHEREAS, the purposes of Rhode Island Food Bank fit within the definition of property exempt from taxation under Rhode Island General Laws 44-3-3(8) and (14),

NOW, THEREFORE, BE IT RESOLVED, that Rhode Island Food Bank be deemed to have been granted tax exempt status with regard to the property located at 170 Niantic Avenue, Providence, Rhode Island, also designated as Tax Assessor's Plat 50, Lot 732 from March 21, 2002, the date of its purchase of said real estate, for as long as it continues to utilize said real estate exclusively for the purposes of said organization.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that taxes that have been assessed for 170 Niantic Avenue, Providence, Rhode Island, for the period of March 21, 2002 to the present, in the amount of Seventy-five Thousand Twenty-nine dollars and nineteen cents (\$75,029.19), be abated.
