RESOLVED, That the Traffic Engineer is requested to cause a Traffic Island to be installed along the junction of Manton Avenue at Atwells Avenue.

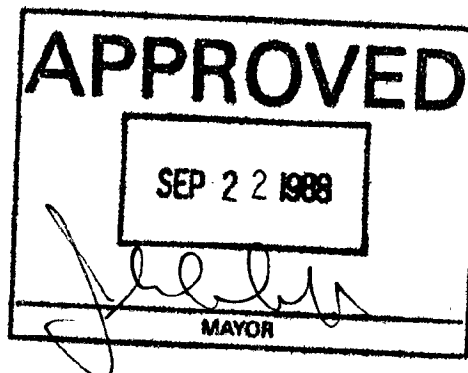

WHEREAS, Linwood Court Apartments is located at that corner in which there are 18 apartments which housed many children,

NOW, THEREFORE, BE IT RESOLVED, That the Traffic Engineer is hereby requested to cause the installation of a traffic signal light at the intersection of Linwood Avenue and Cranston Street.

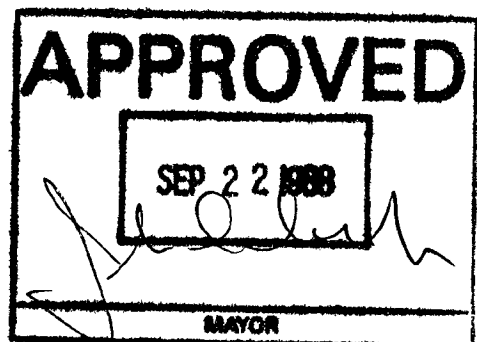

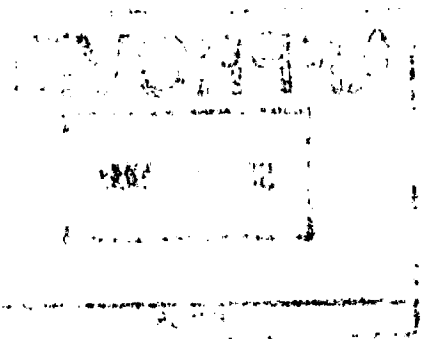

The Linwood Court Tenant Association represents families in the 18 apartments at 102, 104, and 106 Linwood Avenue. We are writing to you because we are concerned about the safety of residents and their children at Linwood Court and in the neighborhood. Specifically, we are concerned about the intersection of Linwood Avenue and Cranston St.


This is a dangerous intersection and needs a traffic light. Because there is no traffic light, cars go too fast down Cranston St. As a result, there have been five car accidents at that corner in the past month. Compounding the problem is the fact that delivery trucks park to unload for the stores, and make visibility of oncoming traffic difficult, and sometimes impossible.

There is a great deal of foot traffic in the area as well, and pedestrians are endangered.

We hope that you will act on this problem right away, and get a street light installed at the corner of Linwood Ave. and Cranston St. Last summer a child was hit by a car there. Please don't wait until it happens again.
