AN ACT in amendment of Sections 5-22-1 and 5-22-5 of the General Laws in Chapter 5-22, Entitled "Shows and Exhibitions", as Amended.

It is enacted by the General Assembly as follows:

Section 1. Section 5-22-1 and 5-22-5 of the general laws in chapter 5-22, entitled "Shows and exhibitions" are hereby amended to read as follows:

"5-22-1. Town regulatory powers. - The town councils and city councils may license, regulate, and in accordance with section 5-22-5 may prohibit and suppress, theatrical performances, rope and wire dancing and all other shows and performances in their respective towns, conforming to law."

"5-22-5. Local licensing of amusements - Prohibition of obscene shows and performances. - Town councils or the board of police commissioners or in the case of the city of Providence, the bureau of licenses, or any other licensing board or authority of any city or town may license such performances, shows, exhibitions, public roller skating in rinks or halls, dances and balls, within their several towns for such term not exceeding one (1) year subject to such regulations and restrictions as they may prescribe; but, except as permitted by sections 5-22-6 to 5-22-11, inclusive, no such license shall authorize any of the aforementioned performances, shows, exhibitions, dances or balls for the first day of the week.

In the event that any town council, board of police commissioners, or in the case of the city of Providence, the bureau of licenses, or any other licensing board or authority of any city or town, shall deny any license for a performance, show, or exhibition on the grounds that such performance, show, or exhibition is obscene, it may refuse to license and may prohibit such performance, show or exhibition for a period of forty-eight (48) hours only; and thereafter, such license shall issue and said prohibition shall be removed, unless the town council, board of police commissioners, bureau of licenses or other licensing board or authority of any city or town shall commence a suit by petition in the superior court for the county in which such town or city is located, for the adjudication of the obscenity of said performance, show, or exhibition, and shall obtain a restraining order barring said performance, show or exhibition until such time as the court shall finally determine the question of the obscenity of said performance, show or exhibition. The superior court shall give precedence to such cases over all other cases in said court except cases of like nature, and such proceedings shall otherwise be governed and conducted as are other causes in equity in the superior court, except that if a restraining order be issued by said court, the respondent may, upon being served with notice of said restraining order, immediately plea, answer or demur to said petition and immediately assign said matter for hearing on the merits, notwithstanding the return day or ordinary assignment day of said cause".

Section 2. This act shall take effect upon its passage and all acts and parts of acts inconsistent herewith are hereby repealed.

WHEREAS, there presently exists no agency of State Government established and operating specifically for the benefit and protection of the consuming public; and

WHEREAS, nearly every major economic interest or bloc has a voice high in government; except the buyer or consumer; and

WHEREAS, individually the members of the consuming public often stand in a disadvantageous position in their dealings with large business interests or corporations, and are, at times, the victims of undesirable business practices by a few less reputable concerns in our community;

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF PROVIDENCE, that the Rhode Island General Assembly is hereby petitioned and urged to adopt Senate Bill S-279, creating a State Consumers Council, which (1) would represent the consuming public in all matters where cost, quality or extent of services and commodities are fixed or regulated by law, and (2) which would conduct research and promote legislation in consumers' interest, promote ethical business and trade practices, develop and disseminate consumer information, appear before government agencies on consumer matters and secure information on rates and services of utilities, interest, insurance, transportation and related areas.





STATE OF RHODE ISLAND CONDEMNATION PLAT NO. 1342





SPOONER ST.




LOT 17 Subdivision in


