Gentlemen:

The Providence Redevelopment Agency, in accordance with the provisions of Chapter 1797 of the Ordinances of the City of Providence approved November 7, 1966 as amended by Chapter 1798 of the Ordinances of the City of Providence approved November 7, 1966 and Title 45, Chapters 31-33 of the General Laws of Rhode Island 1956, hereby reports concerning the proposed sale of real property within the East Side Renewal Project R. I. R-4.

1) The Agency reported to the City Council on August 4, 1975 the proposed sale of Parcel 4 within the East Side Renewal Project to George Macomber d/b/a Benefit Street Town House Company. Mr. Macomber now proposes to take title to the parcel as George Macomber d/b/a Moshassuck Square Development Company for the disposition price of \$24,400.00. Parcel 4 consists of 23,048 square feet of land as delineated on the attached map. The parcel will be developed for residential re-use with the relocation and rehabilitation of one (1) residential structure and off-street parking for area residents in accordance with plans approved by the Agency.
