HOUSE RESOLUTION

RESPECTFULLY REQUESTING THE PROVIDENCE CITY COUNCIL
TO CREATE AND EMPOWER AN AD HOC SUBCOMMITTEE FOR THE
PURPOSE OF FORMULATING EMERGENCY READINESS PROCEDURES
FOR THE CITY OF PROVIDENCE

WHEREAS, The city of Providence, the industrial and business center of the state, is most densely populated during the working day, and accomodates only with difficulty its vehicular traffic during peak travel hours; and

WHEREAS, The evident lack of preparation by the city administration for the blizzard of February 6 and 7, 1978, and the lack of communication by the Mayor of Providence with state and city officials who attempted to contact him during the crisis caused unnecessary confusion, delay, and suffering; now, therefore, be it

RESOLVED, That this house of representatives of the state of Rhode Island and Providence Plantations hereby respectfully requests the Providence city council to create and empower an ad hoc subcommittee for the purpose of formulating emergency readiness procedures for the city of Providence; and be it further

RESOLVED, That the secretary of state be and he hereby is authorized and directed to transmit duly certified copies of this resolution to the mayor of the city of Providence and to the members of the Providence city council.

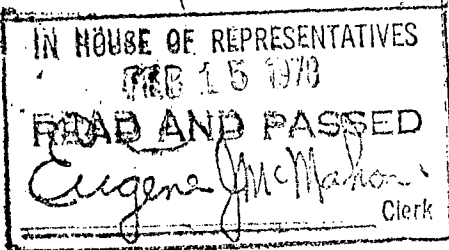
