# State of Rhode Island, &c.

## IN GENERAL ASSEMBLY

JANUARY SESSION, A. D. 19 74.

### AN ACT

TO ESTABLISH WITHIN THE RHODE ISLAND DEPARTMENT OF SOCIAL AND REHABILITATIVE SERVICES, A DIVISION OF FOOD STAMP CONTROL.

*It is enacted by the General Assembly as follows:*

SECTION 1. A Division of Food Stamp Control is hereby established within the Rhode Island Department of Social and Rehabilitation Services.

SEC. 2. The Applicability of Prior Regulations and Conditions.  
The regulations and conditions governing the issuance of food stamps by the Division of Food Stamp Control is subject to all directives of the United States Department of Agriculture and all administrative interpretations or construction by the Secretary of Agriculture, United States of America, of the regulations and conditions shall be conclusive upon all food stamp recipients.

SEC. 3. The Division of Food Stamp Control shall be the issuing agency for all food stamp programs operating in the State of Rhode Island, subject to rules and regulations that it may, from time to time, enact.

SEC. 4. Books and Records. The Division of Food Stamp Control shall maintain such books and records pertaining to the issuance of food stamps as the Division shall prescribe, and shall permit

- (a) the examination of all books, records, documents and memoranda in connection with food stamps.

SEC. 5. This Act shall take effect upon its passage.
