Be it Ordained by the City of Providence:

Section 1. Chapter 1975-12, approved May 8,
1975, entitled, "An Ordinance Implementing the
Provisions of Chapter 256 of the Public Laws of
1974, Authorizing the City of Providence to regu-
late a "Homestead Program" is hereby amended
as follows:

Section 1. (d). lives in, occupies and main-
tains as a single, two or three family dwelling
to city or town housing standards, the parcel

assigned to him for a period of not less than
three (3) years.

Sec. 2. The Homestead Board of the City of
Providence is hereby authorized to accept any
real property donated to the City of Providence
without restrictions as the Homestead Board
deems qualified to fulfill the purposes of the
Homestead Program and all properties so do-
nated to the City shall be utilized for the pur-
poses of the Homestead Program, prior to any
other disposition of the same.

Sec. 3. This Ordinance shall take effect upon
its passage.

Whereas, With the top-level cooperation to the Providence Fire Department were the Department of Communications; the Department of Public Works, and the Fire Fighters and Equipment from the Cities of Warwick, Cranston, East Providence, Pawtucket, and the Towns of Barrington, West Warwick, Central Falls, Johnston, Valley Falls, North Providence, Bristol, Portsmouth, and Swansea, Massachusetts, the holocaust, which was signaled in by the first alarm at 6:55 o'clock P.M. on that evening, erupted into a major four-alarm fire, and

Whereas, Our gallant smoke eaters, under the able direction of Chief Michael F. Moise, contained the problem within the first hour and one half, and controlled it within three and one half hours from the initial alarm, and

Whereas, Notwithstanding the site of the fire in the heavy Downtown District which posed a particular problem, the Fire Fighters were fortified with the benefit of an outstanding Water Supply Service, via, the hydrant system, the sophisticated equipment, which included the two new Ladder Trucks, that rendered an additional water delivery capacity, thereby, what could very well have been a devastatingly spreading fire, was "knocked down" in a remarkable short time,

Now, Therefore, Be It Resolved, That to Chief Michael F. Moise, the Officers and Men of the Providence Fire Department and to the several Departments of the Cities and Towns which sent not less than two pieces of back-up equipment, are hereby extended the sincere appreciation of a grateful Providence Citizenry, as well as the owners and occupants of the affected building, and

Whereas, The sponsor of this Resolution is of the opinion that Deposit Insurance Protection

should be a mandatory requirement for all existing Banks and future Banks in the State of Rhode Island, whether by Charter of the United States Government or by the State of Rhode Island.

Now, Therefore, Be It Resolved, That the proposal of the Director of the State Department of Business Regulation for Mandatory Cover-

age of Personal Bank Deposits for existing and future State Chartered Banks, is hereby unequivocally endorsed.

Whereas, It is becoming increasingly difficult for residents of the City of Providence to procure off-street parking facilities for motor vehicles due to the increased number of motor vehicles owned by residents of the City of Providence,
