





This letter is written in response to your inquiry whether the Judiciary would be affected by the closing of Benefit Street from Waterman Street to College Hill on the days of May 1, 2 and 3, 1982.

During the sixteen years I have been with the Supreme Court there have been several occasions where this section of Benefit Street has been closed to vehicular traffic. On none of those occasions did it interfere with the operation of the courts. Therefore I would have no objection, and it is my personal feeling that the closing of that section of Benefit Street on the days indicated will have no adverse effect on the court and this office has no objection to the closing.
