RESOLVED, That the Traffic Engineer is requested to prohibit motor vehicle traffic along Dorrance Street, between Washington Street and Weybosset Street; Weybosset Street, from Dorrance Street to Exchange Street; Westminster Street, between Dorrance Street and Exchange Street; Exchange Street and all of Kennedy Plaza on Sunday, July 26, 1992, from 7:00 o'clock A.M. to 6:00 o'clock P.M. to accommodate the Pro-Am Cycling Race, in conjunction with The Tomorrow Fund at Rhode Island Hospital, to help children with Cancer.
