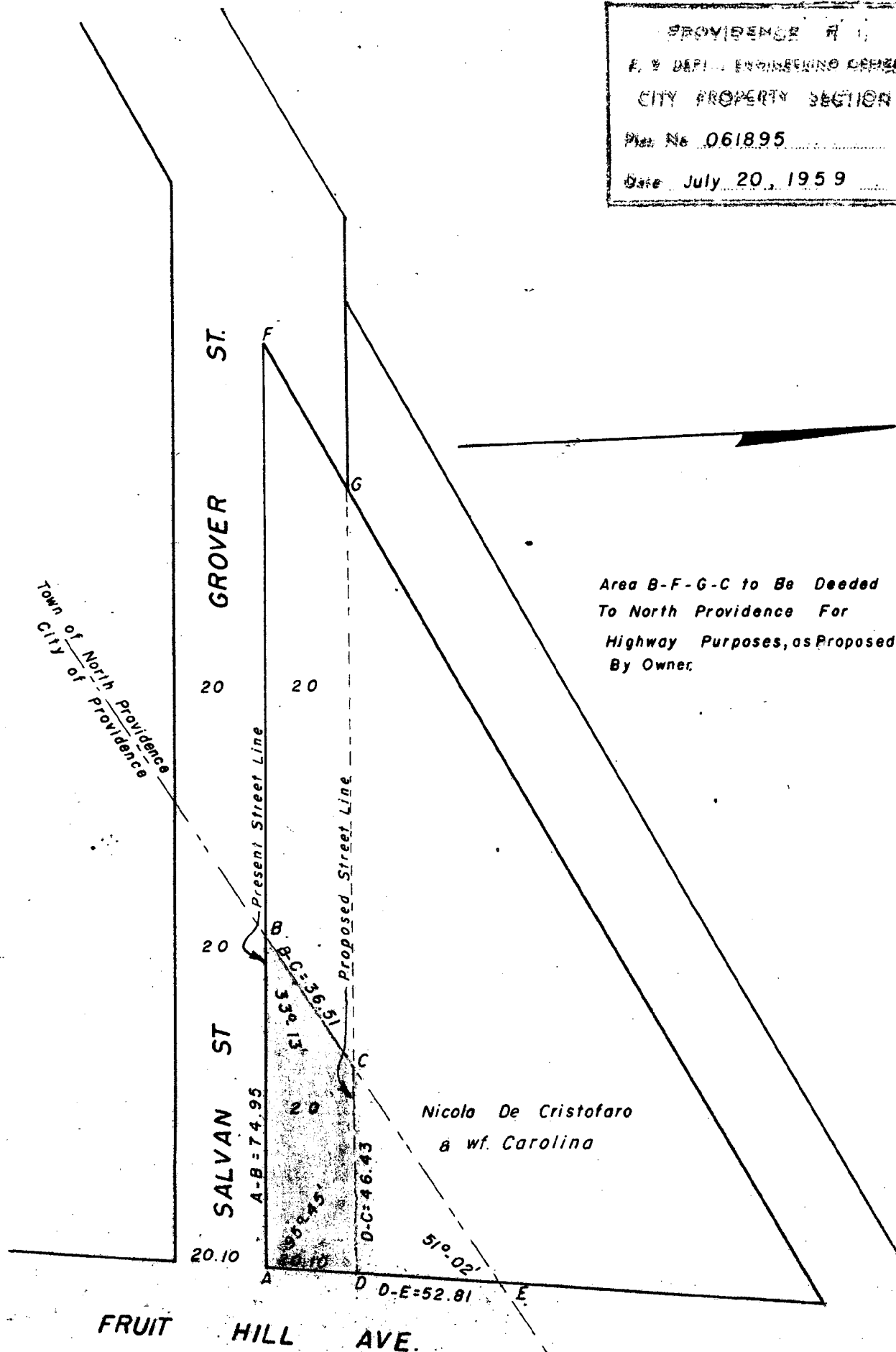

NIAGARA & RODMAN STREETS

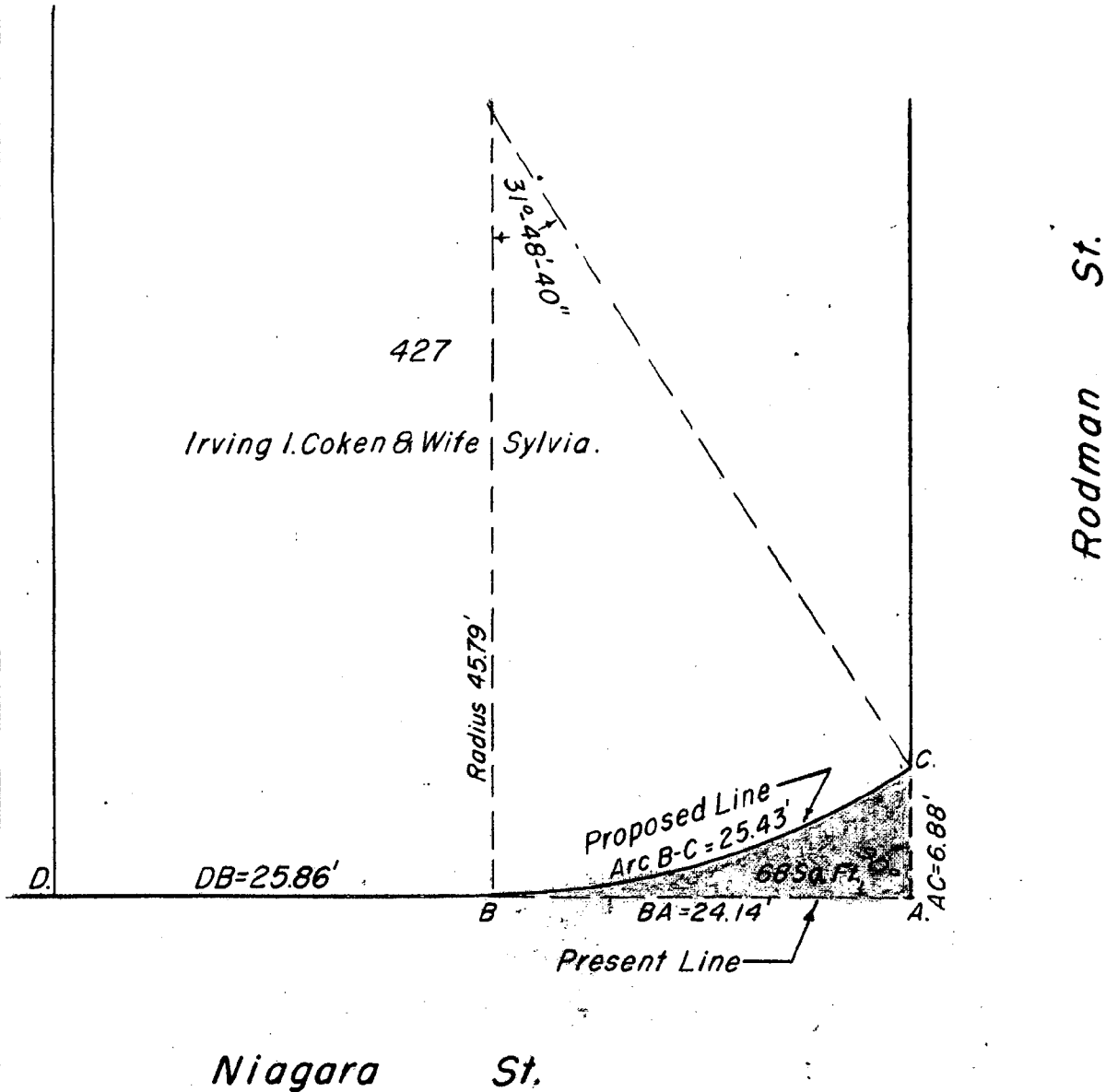
