Thank you very much for your cooperation in this matter.

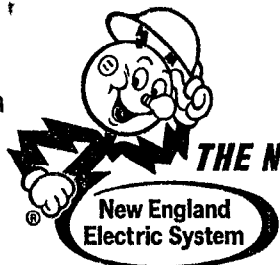

Re: Proposed Easement from City of Providence  
to The Narragansett Electric Company

Dear Mr. Kehoe:

We have carefully reviewed the two proposals which were set forth at the meeting of the Public Works Committee. I have been authorized to request an easement from the City of Providence in the subject area involved, which easement shall be subject to the following terms and conditions:

- 1) Purchase price shall be Twenty-Five Thousand One Hundred Sixty-Three Dollars (\$25,163).
- 2) Easement shall contain a provision indemnifying the City of Providence against claims, law suits, etc., arising out of:
  - (a) Improper or negligent construction, operation or maintenance of the transmission line, including any claim for personal injury or property damage or both.
  - (b) Any claim that the City of Providence did not have the proper authority or legal right to convey said easement to The Narragansett Electric Company.
- 3) The location of any structures on said easement shall be subject to the approval of the Director of Public Works which said approval shall not be unreasonably withheld.
- 4) The said easement is to terminate within five years after the subject easement is no longer used for the transmission of electricity.

I believe that the necessary documents can be drafted after the necessary City Council approval, if said approval is granted.

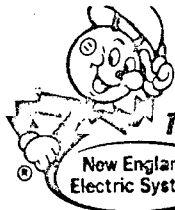

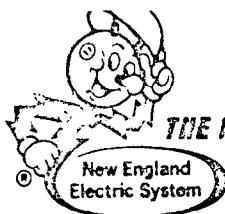
