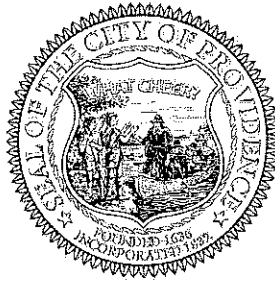

WHEREAS, Public art is a valuable tool for giving neighborhoods a sense of place, to bring communities together, and to beautify the streetscape; and

WHEREAS, Public art has the power to educate, inspire, and enhance people's lives; and

WHEREAS, Many cities around the nation have utilized decorative designs and creative patterns as part of traffic calming efforts at busy intersections, in high pedestrian areas, or near schools; and

WHEREAS, These "creative crossings" help draw attention of drivers, reducing the chance of accidents and injuries, as well as enhancing the appearance of the neighborhood; and

WHEREAS, Placing such artistic crosswalk designs near schools will help to keep children safe on their way to and from school and has the added benefit of promoting art and creativity among our next generation; and

WHEREAS, The Avenue Concept is a local organization dedicated to empowering artists and communities by creating avenues for dialogue and connection through sustainable public art; and

WHEREAS, The Avenue Concept has agreed to work with the City of Providence and the City Council on a Creative Crossings pilot program this summer.

Resolution Requesting the Tax Assessor to cancel or abate in whole the taxes assessed upon Assessor's Plat 019, Lot 120 (5 Exchange Street), on behalf of the Providence Redevelopment Agency, in the amount of One Hundred Eighteen Thousand Eight Hundred Forty Seven Dollars and Sixty Three (\$118,847.63) Cents, and that the property is declared exempt in accordance with Rhode Island General Law 45-32-40 while under PRA ownership.

WHEREAS, Upon receipt of the funds at closing of said transfer or any future transfer: (1) the Agency will be reimbursed for its reasonable expenses directly related to the property; (2) the amount of taxes abated herein will be paid to the City of Providence General Fund; (3) \$50,000 will be paid to the "City Council Parks and Recreation Fund"; and (4) the remaining funds shall be split seventy percent (70%) to the City of Providence and thirty percent (30%) to the Agency.

NOW, THEREFORE, BE IT RESOLVED, That the taxes from the years of 2014 and 2015 , in the amount of \$118,847.63 (One hundred and eighteen thousand, eight hundred and forty-seven dollars and sixty-three cents), assessed upon 5 Exchange Street, Providence, a 24,249 Sq. "Last night me and Councilman Salvatore went to the Classical Athletic dinner that they had at the school. We are all aware, a few of us Council people always think about middle class sports and Classical has always made us very proud. Again, this year it's one of those teams that won super bowls and championships. They've been doing a great, great job over there at Classical High School. Unfortunately, one of the things that we did celebrate was the retiring of Coach Kenny Wnuk after forty years of service to the City of Providence, and to the kids here in Classical, and some of our neighborhoods coaching baseball. Coach Wnuk touched a lot of lives, and as a matter of fact, he had told a story, wish you were there, and it's a good story, so of course our friends at the Journal did not pick it up, and unfortunately it should have been something that we all knew about. There was a young man with cancer that played Classical baseball for the last couple of years and got very ill and fortunately enough we watched over him and his family. Not only did he finish the season this year, but in the very last game he got the winning hit to win the game for their championship baseball team for Classical High School. So, I thought that would be a great thing to hear and to know. But, also I wanted to bring up the retirement of Coach Wnuk and to let everybody know we lost a strong advocate for our youth middle class sports program in Coach Wnuk. And, I just wish him the best of luck as he moves forward, and what I do want to do is I also want to thank Coach Wnuk's family for giving Coach Wnuk to us to help us coach our kids in baseball. Those of you that didn't know Coach Wnuk I don't think there is anyone here that didn't know Coach Wnuk, but those who didn't know Coach Wnuk he was one of the best, he was one of the best and he always treated the kids as his kids. They weren't baseball players, they weren't athletes, they were

his kids when they were on that field. And off that field he spent some time mentoring these kids that weren't fortunate enough to have a mom and dad or aunt and uncle to go home to. Coach Wnuk worked at our field with his practices and stuff because at the time Davey's Field was being fixed up, so he used our field. He did more work down at that field, and no disrespect to the Parks because they do a lot of work, but he did more work to that field as a volunteer than a lot of our employees did down there. He dragged the field, he lined the field, he went above and beyond and I think we really need to send some type of recognition letter by the full council appreciating what Coach Wnuk has done for our kids here in Providence. 
