Dear Sir:

The Annual Report of the Providence Police Department for the Calendar Year of 1959 has now been completed, and it is submitted herewith for your inspection.

You will note in this Annual Report, in comparison with previous years, for the first time appears the activities of the Bureau of Prosecution, a very vital function of the Police Department. It is a fact, based on years of experience by most cities throughout the nation, that consistent arrests and convictions for hazardous moving violations is one of the most efficient, effective and sensible approaches to the problem of reducing the number of costly accidents known to the Police.

Members of various Departments, particularly the Traffic Division, Accident Prevention Bureau, and the Juvenile Bureau appeared on many Television and Radio Programs promoting Safety Programs.

Numerous Associations, such as the Automobile Club of Rhode Island, practically all of the large Fleet Owners of trucks, also all the Utility Companies operating in the City, the Chamber of Commerce of Providence had Officers of this Department speak to their members and drivers on Traffic Engineering, Enforcement and Education during the year 1959, and these talks reflected in a decrease in the year 1959 of 196 traffic accidents of all kinds, the total being 8,099 as against 8,295 the previous year.

Traffic fatalities at the end of 1959 showed a total of thirteen for the entire year, against fifteen for the previous year, but during the month of January 1960 two aged pedestrians succumbed from injuries received in traffic accidents involving busses on the same date, (1959) same street, but in different locations.

Thirteen of the fifteen traffic fatalities were pedestrians, an increase of five pedestrians over the year 1958, three being children, and the remaining ten ranging in age from thirty-five years to eighty-six years. There were no multiple fatalities involving one accident during the year 1959.

At the close of 1959 the use of Radar in detecting speeders on the streets of Providence was in the experimental stage, and

Radar is now being tested and demonstrated on many of the main arteries in the City, and plans for its use in the year 1960 are being considered.

Pupils of all Parochial and Public Schools were instructed by members of the Juvenile Bureau at least three different times in traffic safety, the use of cross-walks, etc., in going and coming from School during the year 1959, and in addition numerous P.T.A. Groups, many Church Groups, Boy and Girl Scout Leaders, and various Mothers' Clubs requested and received permission to have an Officer of the Juvenile Bureau address their groups on safety when crossing streets, and when going and coming from the School Room.

In co-operation with the International Association of Police Chiefs, the following Police Officers of foreign Nations were with this Department receiving on the job training, and learning scientific techniques in modern Police procedure as practiced in this Country. Schedules were arranged whereby they were assigned to work with experienced Police Officers for the purpose of acquainting them with the procedures, policies, and methods employed by this Department, in the particular phase of Police work in which they were interested in. This afforded our Department an excellent opportunity to make comparisons of our system and theirs, and gain some valuable information, and, at the same time promote friendly relations between our Country and theirs by affording them the opportunity to also study our economic principles, our way of life, and the development of our Police program.

From July 6 to July 17, 1959, Tunisian Police Officers Abderrahman B. Ayari and Youssef M. Chergui. Studied at Central Station, Administration, Policies and procedures of foot patrolling and car patrol work, such as; taking reports, investigations within scope of Patrolman's activities...At Traffic Bureau for administration and function of this bureau...At Juvenile Bureau, for administration, functions, investigations, preparation of court cases, etc.

From October 12, to October 30, 1959 Honduras Police Officer, Graces Hardy. Schedule same as above, except that he also spent most of his time with the Detective Division.

From December 14, 1959 to March 12, 1960. Ethiopian Police Inspector Hailu DeGasse. Studing all phases, procedures and techniques employed by the Detective Division in conducting investigations.

Your attention is also directed to the various Charitable Campaigns that were conducted within the Department during the past year, such as the Catholic Charity Appeal; The March of Dimes Collection; The Heart Fund; The United Fund and Multiple Sclerosis Campaign for funds....Members of the Juvenile Bureau were also







JUVENILE BUREAU

During the year 1959 each public, private and parochial school in the City of Providence was visited three times for the purpose of giving safety lectures to the children. Different hazards were pointed out to the children, such as: riding two on a bicycle, using only crosswalks when crossing highways, skating on thin ice, various swimming hazards, etc. This aided greatly in keeping our accident record involving children to a minimum.

Sixty-three lectures were given to church groups and civic organizations on "The Functions and Operations of the Juvenile Bureau", by members of the Juvenile Bureau.

Another successful camping season was enjoyed during the summer of 1959 at the Point Judith Junior Police Camp. Each year 400 boys spend a period of two weeks each at this camp at no expense to them as all expenses are paid by the city. This camp is situated right on the seashore and the average weight gained by the boys during their stay is 5-10 pounds. They are all underprivileged boys that attend this camp. All recreation at the camp is supervised by the members of the Juvenile Bureau and the entire camp is under the direction of the Director of Recreation of the City of Providence. There is approximately \$20,000.00 appropriated annually for the operation of this camp.

Our Junior Police Officers supervise baseball, touch football and basketball games, playing against leagues sponsored by the Recreation Department of the City of Providence, Boys Clubs and the Providence Journal-Bulletin Community League. A keen, but friendly, rivalry exists between the Junior Police Teams and the outside teams. During the 1958-59 basketball season the North End Junior Police team won the championship.

On Halloween night the members of the Juvenile Bureau play host to over 9,000 boys and girls at parties throughout the city. These parties are sponsored by the local merchants and have been very successful and have cut property damage and vandalism down to a minimum. The Children attending are awarded prizes of bicycles, dolls, sporting equipment, games, etc. and have moving pictures, ice cream, soda, candy, pastry and fruit. The Juvenile Bureau has sponsored these parties for the past 14 years.

AMUSEMENT INSPECTOR

Accompanied by the Assistant Amusement Inspector (Sergt. William A. Leonard) attended fourteen (14) private screenings of Foreign Films not having the approval of the Producers Code Authority, Legion of Decency, or when there were no reviews whatsoever available to this Office and the films submitted were of a questionable nature.

Of the fourteen films requiring private screenings not one had been given the Producers Code seal of approval - a self regulatory body of the American Movie producing industry. Six (6) of the films had been condemned by the National Legion of Decency.

Application for the public exhibition of the French film " Love is my Profession " was denied when the management refused to delete several objectionable scenes. After a second private screening for the members of the License Commission, approval was granted only after the suggested deletions were made.

Application for the highly controversial film " And God Created Woman " to be exhibited in the Avon Theatre was denied from this Office, and subsequently approved by the License Commissioners after deletions were effected.

AMUSEMENT INSPECTOR (2)

While films considered of an objectionable nature have been confined to the so called " Art Houses ", namely the Avon and Art Cinema Theatres, during the year 1959 bookings of condemned films were received for neighborhood Theatres. After a conference with the owner the film in question was withdrawn and an agreement reached that this type film will not be exhibited in the neighborhood or family theatres.

Many complaints were received in this Office regarding the suggestive and off color advertisements by the Theatres in the local press. All were referred to the press resulting in withdrawal of two of the ads complained of and an understanding of more control in the future. Many newspapers throughout the country becoming cognizant of the attempt to exploit sex in Theatre advertisements have ordered closer editing of same.

Reviews of Motion Pictures and Legitimate stage productions together with their entertainment value have been received under subscription from:

Motion Picture Herald, containing a number issued by the Producers' code authority to moving pictures produced that meet with their standards. The PCA being a self regulatory agency of the American Film Industry.

National Board of Review of Motion Pictures - Magazine : Publishing the book "Films in Review" containing reviews of many films produced abroad as well as in this country.

Variety, a trade paper of the Entertainment World, known for its unbiased reporting.

The Green Sheet, containing film estimates by several organizations, including the Protestant Motion Picture Council and the American Jewish Committee.

National Legion of Decency: A Catholic organization which evaluates and then classifies most of the films exhibited in this country.

The reviews received weekly from the above organizations have been filed both alphabetically and numerically in the Library of this Office for immediate reference.

In cooperation with the State appointed Rhode Island Commission on Youth, letters were received in eight instances naming a total of 26 publications as objectionable for youths under 18 years of age for distribution, or selling to. Hundreds of visits to news-stands by men assigned to this Division were made in a manner of cooperation and the objectionable material removed.

AMUSEMENT INSPECTOR (3)

During the year 1959 considerable effort was expended in an attempt to rid the news-stands of indecent literature and girlie type magazines. As the result of an arrest made by this Division and the court procedure that followed, the Rhode Island State Obscenity Law was ruled un-constitutional and recommendations for a new law were forwarded to the Attorney General. A new obscenity law was enacted by the Rhode Island Legislature subsequently.

Three arrests were made by this Department during the past year, of dealers in obscene material, two by men assigned to this Division and one by members of the Detective Division. No doubt these arrests, the seizure of objectionable material and the attendant publicity, together with other arrests throughout the State have been a great deterrent to the sale and possession of objectionable material on the news-stands. The Secretary to the Rhode Island Commission to Encourage Morality in Youth has made a public statement that the 'girlie type' magazines have practically vanished from the stands.

BUREAU OF PERSONNEL AND TRAINING

Recruit Schools

During the year 1959 one recruit school was conducted at this division. The twenty-third school started October 19, 1959 and they will complete their course of training April 17, 1960. A total of 17 men were recruited in this school, and this brought the personnel over the prescribed authorized strength because there were only 10 vacancies at that time. This left 7 over which is permitted by city ordinance. Since that time we have had 10 more vacancies during the last 3 months which leaves us 3 men short of our authorized strength. Consequently it will be necessary to convene another school during the coming year when sufficient separations take place to warrant starting another class.

School Crossing Guards

This type of work continues to prove very attractive as a parttime position with only 4 resignations being tendered during the year 1959. Any vacancy that occurs can be easily filled as there are applications on file from aspirants from all sections of the city. They are a valuable asset to the city, and perform their duties in a capable and efficient manner, complaints are few, and consequently they need a minimum of supervision which permits officers more time to devote to other police work that normally demands their attention. By their conscientious effort they have gained the respect and admiration of the children they supervise. This strong bond of friendship enables them to exercise a firm hand in controlling the children at the various crosswalks, and this is reflected in the low accident rate of children of school age.

Promotional Schools

It was not necessary to conduct a promotional school during the year 1959. At present there is a vacancy in the rank of Lieutenant and the certified list of Sergeants eligible for promotion to this rank was used up this past year. Therefore it will be necessary to conduct a school in the near future in order to establish a list of men eligible for promotion to fill any vacancies that may occur in the rank of Lieutenant. The following promotions were made of men who attended promotional schools, during the year 1959, 2 Sergeants promoted to the rank of Lieutenant, and 5 patrolmen promoted to the rank of Sergeant.

Refresher School

Starting January 6, 1959 and running for a period of 12 weeks, which terminated March 26, 1959 a refresher course was conducted for members of the uniform force of Central Station. A total of 272 men attended this course, and among the many points stressed were; police procedures, department policies, courtesy and public relations. During the weeks of April 7 and April 15, members of the Traffic Bureau reported for their refresher course, and a total of 64 men were in attendance during this 2 week session. The purpose of holding these courses was to bring about adjustments that would be beneficial to the men and department in order to provide the city with a more efficient police force. It was felt that this was accomplished, because the men were able to present problems and procedures that were not being followed, and immediate steps were taken to bring about a uniformed execution of police procedures and practices.

Pistol Qualification for Department

This year a change was made instead of firing at the Standard American Target, the practical police course was fired by all members of the department at the Colt Silhouette Target. This course of firing is as follows; 10 shots double action from the 7 $\frac{1}{2}$ yard line, 5 shots prone from the 60 yard line, then 5 shots prone, 5 shots sitting, 5 shots with the right hand from behind the barrier, and 5 shots with the left hand behind the barrier from the 50 yard line, then 5 shots with the left hand behind the barrier, 5 shots with the right hand behind the barrier, and 5 shots kneeling beside the barrier from the 25 yard line for a total of 50 shots fired on the Colt Silhouette Target.

Department Pistol Team

During the past year members of the department were given the opportunity to try-out for a pistol team to represent the department. The five highest averages of the men who participated in this preliminary competition were selected for a team. The team then engaged in a series of matches with the Rhode Island State Pistol Team, and they were able to register a decisive victory. This team was not formed until late in the summer, and it is expected that more matches with neighboring pistol teams will be scheduled during the year 1960.

Auxiliary Police and Police Reserves

The Providence Police Reserves were very active again this year lending assistance to the department whenever called upon. They participated in the local Civilian Defense Operation "Alert" by furnishing men for traffic control at the Scituate Headquarters during this drill. They also took an active part during the Fourth of July and Halloween observances by patrolling selected trouble spots, and this was a great factor in holding vandalism to a minimum. This year they received pistol instruction under the supervision of Sergt. Noel Pinney, Department Armorer and then qualifications were held at the Scituate Pistol Range, and 16 members of the Reserve qualified. They are to be commended also for their contribution to the Muscular Dystrophy Campaign in which they worked 700 man-hours in distributing containers and then collecting them which resulted in \$1,725.50 being collected for this worthy cause.

Twenty-third School, started October 19, 1959 and their course of training will be completed April 17, 1960. The following are statistics relative to this school:

ACTIVITIES OF THE BUREAU OF CRIMINAL IDENTIFICATION

January 1st. to December 31st., 1959

NOTE:

During the past year considerable progress has been made on the tremendous task of modernizing and revising the fingerprint files. This has entailed the expenditure of hundreds of man-hours, but is vitally necessary to the efficient operation of these files as this is the first major overhaul undertaken since the institution of fingerprinting in this Department.

In conjunction with the fingerprint file project we are also proceeding with a revamping and replacement program designed to insure the efficiency of the master record file.

In early February of 1959 Lieut. Walter Cahill attended a course on "The latest developements in fingerprinting" under the auspices of the Federal Bureau of Investigation at Boston, Massachusetts and has indoctrinated the B.C.I. personnel in the newest techniques.

Extensive research and experimentation in the medium of color photography has been carried out throughout the year by the entire personnel of the Bureau.

ACCIDENT

PREVENTION

BUREAU

During the year of 1959, the Accident Prevention Bureau worked closely with the following organizations in the dissemination of traffic safety and accident prevention material: the local press, radio and television stations, the Mayor's Traffic Safety Committee and the Chamber of Commerce. The support given the Accident Prevention Bureau was practically unlimited.

Fifteen traffic fatalities were recorded for the City of Providence, R.I. for the year of 1959, the same total as the previous year. Thirteen of the fifteen fatalities were pedestrians, an increase of five over the previous year. Three of these pedestrians were children; and the remaining ten ranged from age thirty-five to eighty-six.

PEDESTRIAN SAFETY CAMPAIGN

Pedestrian accidents during the first four months of 1959, showed a considerable increase over the previous year, with this a Pedestrian Safety Campaign was inaugurated and more than 5,000 warning cards with safety messages printed on them were passed out in the downtown area along with safety messages from sound cars, in an effort to persuade walkers to take the path of safety. They were presented to adults who made their crossings between blocks other than marked walks or intersections where vehicular traffic is controlled by traffic lights.

TRAFFIC SAFETY LETTERS AND POSTERS

With the opening of the new school year, Patrolmen of the Juvenile Bureau who lecture in the schools on traffic safety distributed letters on this subject to the younger children in an effort to alert them on the dangers of traffic accidents. Along with this program traffic safety posters were placed on poles near schools so as to alert motorists as to the opening of school.

WARNING LETTERS

A total of 605 warning letters were sent to persons who operated motor vehicles in excess of the speed limit, which didn't warrant prosecution, asking them to cooperate with the police department in its continued efforts to lessen the loss of life and ever increasing amount of property damage resulting from careless and inattentive operation of motor vehicles upon our highways.



SUMMONSES PREPARED AND SERVED

During the year there were 31,627 Summonses with duplicate copy prepared and served through the Bureau of Prosecution.

There were 2,716 persons named in summonses who failed to appear as directed and who were later located and resummoned, to appear in Providence Police Court, and 4,133 re-summoned to appear in the Sixth Judicial District Court.

PREPARING AND MAINTAINING COURT DOCKETS

Dockets of the Sixth Judicial District Court and the Providence Police Court are prepared and arranged by this Bureau after date of Trial has been determined by the Courts. Witnesses are summoned, different Divisions prosecuting cases are contacted and defense attorneys informed of the trial date. Contents of the Docket is examined the day previous to the Trial day by the Judge of the Court and a member of the Bureau.

BUREAU OF PROSECUTION (3)

ATTENDANCE IN COURT

One member of this Bureau is present each day in each of the two Courts to present evidence in all Traffic Violations and record date of trial, if one is to be held. Warrants are subscribed to and delivered to the Judge of the Court just previous to the start of the Court session.

SAFETY LECTURES IN SIXTH DISTRICT COURT

From 9:00 A.M. to 9:30 A.M. Monday, Wednesday and Friday of each week the Judge of the Sixth Judicial District Court holds a "Traffic Court" at which he lectures on safe operation of motor vehicles to all assembled to answer summonses for violation of the motor vehicle laws.

Large photographs, charts and statistics are prepared by the Prosecution Bureau for the use of the Judge in these talks. Each month a report on the prosecutions for the previous month is prepared and presented to the Judge for comparison.

IDENTIFICATION OF PARKING LAW VIOLATORS

Each day a member of this Bureau visits the Registry of Motor Vehicles at the State Office Building to check registration numbers recorded on each Blue Tag issued and which has not been answered for payment within five days from day it was issued. The owner is identified and a Warrent and Summons prepared for Court appearance.

CRIMINAL CHARGE FILE:

Complete index and charge card file on all criminal laws listed in the 1956 General Laws of Rhode Island, was completed in the early part of this year in cooperation with the City Solicitor's Office. Complete set of these laws together with an index was delivered to each Division in the Police Department.

Amendments to the existing laws and all new laws enacted by the Legislature are recorded in this file after the charge has been dictated by the City Solicitor and each Division file is also corrected.

CASES REPORTED TO GRAND JURY

During the month of November this Bureau prepared a report on 16 cases which was forwarded to the Attorney General to be considered for presentation to the Grand Jury. All cases reported, accuse a defendant who for different reasons has not been apprehended by the Providence Police Department. All are cases which have either been arraigned in District Court or Warrent issued by that Court and the person not apprehended. Because the Statute of Limitations prevails in many of these cases and because the time limit is 3 years, it was determined to present the same for Indictments by the Grand Jury. This is a new procedure requested by the Sixth District Court Justice.

WARRENTS OBTAINED ON REQUEST:

During the year this office prepared 102 Warrents for the arrests of persons accused after investigations by the Police. Such Warrents, after being approved by the Chief and issued by the District Court Judges, are delivered to the Division requesting same. There are 62 of these Warrents outstanding.
