Approved March 25, 1971

Be it ordained by the City of Providence:

SECTION 1. Chapter 70-26 of the Ordinances of the City of Providence as approved June 23, 1970, and entitled: "An Ordinance Making Appropriation of \$67,836,687.18 for the Support of the City Government for the Fiscal Period Beginning July 1, 1970 and Ending June 30, 1971", as amended, is hereby further amended by appropriating the sum of Twenty-Nine Thousand (\$29,000) Dollars to BOARD of CANVASSERS, ITEM O.

SECTION 2. The said sum of Twenty-Nine Thousand (\$29,000) Dollars as hereby appropriated shall be charged to General Fund from Funds Not Otherwise Appropriated.

SECTION 3. The City Controller and the City Treasurer are hereby authorized and directed to pay over Twenty-Nine Thousand (\$29,000) Dollars to the Board of Canvassers Account.

SECTION 4. This Ordinance shall take effect upon its passage.

# RESOLUTION OF THE CITY COUNCIL

No. 167

Approved March 24, 1971

WHEREAS, representatives of Parochial Schools, within the City of Providence, have requested of the Providence School Committee that Public School Teachers be assigned to teach some of the secular subjects in Parochial Schools, starting in September, 1971, which would aid a dangerous financial situation existing in many of the parish schools within the City, and

WHEREAS, the City of East Providence; the Town of North Providence, and in Pascoag, a plan, similar to that requested, is being employed and has proven to be of great merit and financial aid to those municipalities, and

WHEREAS, such teaching assistance, if granted, it would appear that the Parochial Schools could continue to offer proven quality education and not be forced to close, as has already been the case in some instances.

NOW, THEREFORE, BE IT RESOLVED, that the said Providence School Committee is requested to meet with Reverend Father Edmund Mullins, Superintendent of Diocesan Schools for the purpose of implementing a plan of assigning Public School Teachers to assist in teaching certain secular subjects in Parochial Schools, starting September 1971 for the 1971 - 1972 school year, thus alleviating what would be a serious financial burden upon the taxpayers of the City of Providence, if additional Parochial Schools in Providence were forced to close, and

BE IT FURTHER RESOLVED, that the Chairman of the Committee on Finance, or member or members of said Committee, be in attendance at all of such meetings.

AN ACT RELATING TO THE PROVIDENCE CIVIC CENTER AUTHORITY.

It is enacted by the General Assembly as follows:

SECTION 1. Section 5 of chapter 3 of the public laws of 1969 is amended by striking the first, second and third sentences thereof and substituting the following two sentences: Any lease by the authority to others of any portion of the civic center, or any concession granted by the authority with regard thereto, shall contain such provisions as to the use and operation thereof and as to admission thereto as the authority may deem necessary to facilitate the public use and benefit to be derived from the civic center. The term of any such lease or concession, including any renewals or extensions at the option of the lessee or concessionaire, shall be such as the authority deems necessary to facilitate the effective use of the civic center for the purposes of this act, but no such term shall exceed thirty years.

SECTION 2. This act shall take effect upon its passage.

### AN ACT

IN AMENDMENT OF CHAPTER 832 OF THE PUBLIC LAWS OF RHODE ISLAND, JANUARY SESSION, 1940, ENTITLED "AN ACT TO REVISE, CONSOLIDATE AND AMEND CHAPTER 598 OF THE PUBLIC LAWS OF 1866 ENTITLED 'AN ACT TO REVISE, CONSOLIDATE AND AMEND THE ACT ENTITLED "AN ACT TO INCORPORATE THE CITY OF PROVIDENCE", AND THE SEVERAL ACTS IN ADDITION THERETO AND IN AMENDMENT THEREOF", CREATING A FINANCE DEPARTMENT IN THE CITY OF PROVIDENCE, AND IN AMENDMENT OF THE PUBLIC LAWS OF 1945, CHAPTER 1665, SECTION 5.

*It is enacted by the General Assembly as follows:*

Section 1. Chapter 1665, Section 5 the Charter of the City of Providence, is hereby amended to read as follows:

"All purchases made and contracts executed by the purchasing agent shall be pursuant to a written requisition from the head of the office, department or other agency whose appropriation is to be charged; and no purchase order shall be issued or contract executed, nor shall any other agreement purporting to obligate the city be entered into unless and until the controller certifies that there is to the credit of the department, board, commission, bureau or other city agency concerned therewith a sufficient appropriation balance in excess of all unpaid obligations, to defray the cost of such supplies, materials, equipment or contractual services; and unless and until the budget director certifies that the purchase is consistent with policies established in the budget.

Competitive bids shall be obtained where practicable for all purchases and for all

public improvements not made by city departments or agencies. Contracts shall be awarded to the lowest responsible bidder except in cases where it is clearly to the advantage of the city to award the contract to some other bidder. Sealed bids shall be required in all transactions amounting to or in excess of ~~five-hundred dollars-(\$500.00)~~. fifteen hundred dollars (\$1,500.00).

Such bids shall be secured through public advertisement, shall be submitted to the city clerk and shall be publicly opened by the purchasing agent."

Section 2. This Act shall take effect upon its passage, and all Acts or parts of Acts inconsistent herewith are hereby repealed.

*It is enacted by the General Assembly as follows:*

Section 1. Chapter 1665, Section 16, Paragraph (a) the Charter of the City of Providence, is hereby amended to read as follows:

"In the exercise of his duties relating to the budget the finance director shall have authority as hereinafter provided:

(a) Requiring work programs; approved allotments.

To require the head of each department, board, commission, bureau, or other agency of the city, after the annual appropriation ordinance has been adopted by the council and before the beginning of the fiscal year, to submit a work program for the year, which program shall include all appropriations for its operation and maintenance and purchase of equipment and shall show the requested allotments of such appropriations for such appropriations for such department or agency by months-or-quarterly for the entire fiscal year as the mayor may direct. Said finance director shall review the requested allotments in the light of the work program and, with the approval of the mayor, may revise, alter, or change such allotments before authorizing the same. The aggregate of such allotments shall not exceed

the total appropriation available to such department or agency for the fiscal year. The controller shall authorize all expenditures to be made from the appropriations on the basis of the approved allotments and not otherwise. The approved allotments may be revised during the fiscal year after application therefor by the head of any department, board, commission, bureau or other agency of the city, and approval by the mayor."

Section 2. This Act shall take effect upon its passage, and all Acts or parts of Acts inconsistent herewith are hereby repealed.

### AN ACT

IN AMENDMENT OF AND IN ADDITION TO CHAPTER 489 OF THE PUBLIC LAWS OF 1923, ENTITLED "AN ACT TO PROVIDE FOR THE RETIREMENT OF EMPLOYEES OF THE CITY OF PROVIDENCE", AS AMENDED.

*It is enacted by the General Assembly as follows:*

SECTION 1: Subdivision (7) of Section 9 of Chapter 489 of the Public Laws of 1923, as amended, is hereby amended to read as follows:

"(7) Once each year the retirement board may, and upon his application shall, require any disability pensioner under the minimum age for service retirement to undergo a medical examination, such examination to be made at the place of residence of the pensioner or other place mutually agreed upon, by a physician or physicians engaged by the retirement board. Should any such pensioner refuse to submit to such examination, his pension may be discontinued until his withdrawal of such refusal, and should his refusal continue for a year, all his rights in and to such pension may be revoked by the retirement board. If the examination indicates that the disability of the pensioner has been removed, his name shall be placed on such appropriate lists of candidates as are prepared for appointment to a position in his department for which he is stated to be qualified in a salary grade comparable to that from which he was last retired. Upon reinstatement to active service at the salary grade comparable to that from which he was last retired, he shall be reinstated as a member and participate in the benefits of the retirement system with credit for service rendered prior to disability retirement and for the period during which he received the disability retirement allowance, provided that he did not refuse to accept such reinstatement when it was first offered to him; in the event of such refusal, the pension shall be discontinued and any rights to further benefits under the retirement system shall be based solely on his service rendered prior to his disability retirement."

SEC. 2. This Act shall take effect upon its passage and all acts or

parts of acts inconsistent herewith are hereby repealed.
