No. 247 AN ORDINANCE

AMENDING THE APPROPRIATION ORDINANCE
CHAPTER 1974-19 APPROVED JUNE 19, 1974 BY APPROPRIATING
THE SUM OF TWENTY FIVE THOUSAND, (\$25,000.00) TO
CONTINGENCIES-1-13-01-ITEM 1.

Approved April 9, 1975

Be it ordained by the City of Providence:

SECTION 1. Chapter 1974-19 of the Ordinances of the City of Providence, as approved June 19, 1974 entitled: "An Ordinance Making Appropriation of \$85,823,307.71 for the Support of the City Government for the Fiscal Period Beginning July 1, 1974 and Ending June 30, 1975" as amended is hereby further amended by appropriating the sum of Twenty Five Thousand Dollars (\$25,000.00) to Contingencies-Item 1.

SECTION 2. The said sum of Twenty Five Thousand Dollars (\$25,000.00) as thus added shall be obtained by authorizing The City Controller and City Treasurer to transfer Twenty Five Thousand Dollars (\$25,000.00) from the Reserve for Extraordinary Expenditures account to the Receipt account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures account are hereby increased by Twenty Five Thousand Dollars (\$25,000.00).

SECTION 4. This Ordinance shall take effect upon its passage.
