Dear Councilwoman Young:

In reference to the proposed resolutions that would change One Weybosset Hill to One Cookson Place and the current One Cookson Place to One Union Station, I believe that this type of change tends to compromise the excellent numbering system the City of Providence now maintains.

Presently, the City has approximately 25 buildings in the downtown area that have been assigned out-of-sequence or unique addresses. If we (jointly) allow this practice to continue we will be adding to the frustration of not only the postal service, but of other delivery companies and visitors to the downtown area. I suggest that your Committee take these issues into consideration when reviewing the proposed changes.

Our recommendation for the One Weybosset Hill address is to change the address to One Broad Street. This was the original address of the building and would put it back into the correct sequence.

Our recommendation for the One Cookson Place building is to return it back to the original address of 40 Exchange Terrace. This was the original address of the building and would put it back into the correct sequence.

✓ We recommend approval of the proposed resolution to change that portion of Brownell Street beginning at Francis Street and ending at Park Street to Avenue of the Arts. We presently see no problems with this change, as we have no deliveries on the portion of the street.

I would like to express my appreciation for your notifying the Postal Service of the proposed resolutions for the City of Providence and I hope that our input is of assistance to you and the City Council in making a decision. If it would be beneficial, we would be more than willing to sit down to discuss this or any other addressing issues with you or members of your committee.
